- I. **Call to Order/Introductions/Opening Remarks:** Meeting called to order by OCCJCC Co-Chair Supervisor Chaffee.
- II. **Review and Approval of Minutes:** Meeting Minutes of April 15, 2022, were approved. The motion was made by Acting-Chief Probation Officer Bryan Prieto, Seconded by Chief Stu Greenburg, Tustin Police Department. Approved unanimously.
- III. **Approval of OCCJCC Bylaws:** Bylaws were approved. The motion was made by Acting-Chief Probation Officer Bryan Prieto, Seconded by Sheriff Don Barnes. Approved unanimously.
- IV. **OCCJCC Updates**
 - a. **Summary -Corrections Cohort Data Integration Offsite:** An update was provided by Deputy County Executive Officer Lilly Simmering regarding the offsite held on May 3, 2022, and the next steps which may involve a pilot project with local law enforcement.
 - b. **Public Information Campaigns:** A presentation was made by Mark Lawrenz, HCA – Division Manager for Prevention and Early Intervention, on several of their campaigns including OC Links, Stigma Free OC, Mental Health Awareness Month, and the OC Navigator website and the promotional campaign with Angels baseball.

- c. **Office of Care Coordination:** Doug Becht, Office of Care Coordination Director, provided an update on the reorganization of his unit under the County Executive Office effective July 1st.
 - d. **Expansion of SUD Services for Adolescents:** A presentation was made by Dawn Smith, HCA - Director of Children, Youth and Prevention Services, on the substance use disorder treatment services for youth and the programs for different levels of care.
 - e. **Revisions to County's Housing Strategy:** An update was provided by Dylan Wright, Director of OC Community Resources on the County's Housing strategy and incorporating the results from the recent Point-in-Time Count and the reentry population.
- V. **OCCJCC Comments:** Public Defender Marin Schwarz shared that with the Courts ending remote appearances on June 30th, there is some concern on workload as the caseloads in his department are the highest they have ever been.
- VI. **Public Comments:** One public comment was submitted by Carole Urie from *Returning Home Foundation* regarding Senate Bill 1008, Corrections: telecommunications, that is pending and may impact the revenue received for inmate programming.
