Continuum of Care (CoC) Board Vacancy

- In April 2022, the Office of Care Coordination was notified by Albert Ramirez, who was elected to the CoC Board as the Emergency Solutions Grant (ESG) Program Funded Agency or Recipient Agency Representative, of his resignation from the City of Anaheim and Orange County CoC involvement.
- The Office of Care Coordination is recommending the establishment of a Nominating Committee with the following CoC general members to be appointed to the Nominating Committee: Barry Ross, Elizabeth Andrade, David Gillanders and LaVal Brewer and a member of the CoC Board.
- The appointment of the Nominating Committee by the CoC Board will support with the next steps of the process as outlined in the Governance Charter and will ensure representation in the CoC Board and adherence to the Homeless Emergency Assistance and Rapid Transition to Housing (HEARTH) Act.

CoC Membership Term Extension

- In July 2021, the CoC Board appointed the membership of the Nominating Committee to facilitate a review of the CoC Board membership composition and election process as detailed in the Governance Charter, as well as provide recommendations to best enhance the composition of the CoC Board and improve the election process.
- There are currently eight (8) CoC Board members whose terms are set to expire on June 30, 2022: Christina Weckerly-Ramirez, Matt Bates, Judson Brown, Soledad Rivera, Donald Dermit, Tim Houchen, Patti Long and Maricela Rios-Faust.
- Approval to extend the CoC Board member term date to December 31, 2022, for the listed members to align with the updated Governance Charter will allow for a continuation of current CoC Board leadership and ensure a smooth transition to establishing membership terms in future election cycles.

Approve extending the CoC Board term to December 31, 2022, to align with the updated term dates included in the CoC Board Governance Charter for the following CoC Board members: Christina Weckerly-Ramirez, Matt Bates, Judson Brown, Soledad Rivera, Donald Dermit, Tim Houchen, Patti Long and Maricela Rios-Faust.

HMIS Access Working Group

- In April 2022, the Office of Care Coordination was made aware of a vacancy within the HMIS Access Working Group.
- The Office of Care Coordination met with the HMIS Access Working Group to gather nominations for consideration to fill the vacancy.
- The nominees were discussed with the HMIS Access Working Group in effort to identify CoC stakeholders who are knowledgeable in HMIS policies, procedures and practices and able to work in a collaborative setting.
- As such, the following individuals are being recommended for membership: Deby Wolford from Illumination Foundation and Linda Ly from City of Anaheim.

CoC Vision Ad Hoc

- On February 20, 2021, the Orange County CoC Board approved the creation of a CoC Vision Ad Hoc.
- The CoC Vision Ad Hoc met several times to review the available data of the Orange County CoC including the Housing Inventory Chart (HIC), Point in Time (PIT), Longitudinal System Analysis (LSA), System Performance Measures (SPM) Report and Quarterly CoC Data Dashboard.
- Convening the CoC Leadership Vision Ad Hoc with a focus on the LSA data will help streamline strategies and efforts to achieve measurable goals for the Orange County CoC.
- The following CoC Board members are recommended for the CoC Leadership Vision Ad Hoc: Tim Shaw, Patti Long, Becks Heyhoe, Dawn Price and George Searcy.

CoC Notice of Funding Opportunity (NOFO) Ad Hoc

- Each year, the U.S. Department of Housing and Urban Development (HUD) releases a Notice of Funding Opportunity (NOFO) that allows CoCs nationwide to apply for competitive funding.
- The upcoming Fiscal Year (FY) 2022 CoC NOFO is anticipated to be released by HUD in mid-June to July 2022.
- The CoC Board is tasked with appointing a CoC NOFO Ad Hoc to support with the local competitive process to evaluate renewal project performance, establish funding priorities for new and reallocated funding, establish policies for reallocation and rating and tiering CoC projects.
- The CoC NOFO Ad Hoc is to be comprised of non-conflicted members of the CoC Board and will be tasked with providing unbiased recommendations to the CoC Board around the FY2022 CoC Program NOFO.
- Recommended membership for the CoC NOFO Local Process Ad Hoc includes Eric Richardson, Becks Heyhoe and Tim Shaw.

History of HHI

- Goal Enhance and strengthen the delivery system to better meet the needs of individuals experiencing homelessness
 - March 2019 Board established an Ad Hoc committee
 - April 2019 Made \$100 million commitment
 - December 2019 Board adopted HHI Guiding Principles

HHIP Overview

- DHCS incentive program available to Medi-Cal managed care plans (MCP) to incentivize investments in the community and progress made in addressing homelessness and keeping people housed
 - Funds provided as operational and performance metrics are met
 - 85% of incentive funds must go to beneficiaries, providers, local Continuum of Care or counties

DHCS Proposed Strategic Approach

Program Vision, Goals & Strategic Approach

Drawing on the HCBS Spending Plan and the DHCS Quality Strategy, DHCS proposes the following program vision, goals, and strategic approach that will guide and shape the design and implementation of HHIP.

VISION: improve health outcomes and access to whole person care services by addressing housing insecurity and instability as a social determinant of health for the Medi-Cal population

PROPOSED GOALS

Ensure MCPs have the necessary capacity and partnerships to connect their members to needed housing services

Reduce and prevent

PROPOSED STRATEGIC APPROACH

- Develop partnerships between MCPs and social service agencies, counties, public health agencies, and public and community-based housing agencies to address homelessness
- **Provide** rapid rehousing for Medi-Cal families and youth, and interim housing for aging and disabled populations
- Expand access to housing services and street medicine programs
- Improve access to coordinated housing, health and other social services
- Reduce avoidable use of costly health care services
- **Improve** whole person health for Medi-Cal enrollees, including behavioral health treatment and resources
- Implement solutions that manage information to better identify populations of focus and Member needs



Population Served

 DHCS has provided a definition for individuals who are experiencing homelessness and are at risk of homelessness*

Experiencing homelessness is defined as:

- An individual or family who lacks adequate nighttime residence;
- An individual or family with a primary residence that is a public or private place not designed for or ordinarily used for habitation;
- · An individual or family living in a shelter;
- · An individual exiting an institution into homelessness;
- · An individual or family who will imminently lose housing in next 30 days;
- Unaccompanied youth and homeless families and children and youth defined as homeless under other federal statutes; or
- Individuals fleeing domestic violence.

*Aligns with the Community Supports Policy Guide and the Housing and Urban Development (HUD) definition provided in Section 91.5 of Title 24 of the Code of Federal Regulations (CFR).




HHIP Information

- Letter of Intent submitted to DHCS March 22, 2022
- Local Homelessness Plan due to DHCS June 30, 2022
- Must partner with local Continuums of Care, public health, county BH, public hospitals, county social services, and local housing departments
- DHCS guidance for LHP:
 - Build off existing local HUD or other homeless plans and map existing services
 - Outline how services will be offered, referrals will be made, how other funding streams will be leveraged or braided, and how progress will be tracked toward goals

CalOptima's Letter of Intent (LOI)

• Preliminary goals identified include

- Design/implement robust street medicine model that provides preventive and urgent care, promoting continuity of care
- 2. Increase Medi-Cal enrollment among individuals experiencing homelessness who are eligible for CalOptima
- 3. Integrate CalOptima systems with CES used for getting individuals into housing by establishing effective data matching and sharing operating procedures

- Consolidate HHAP Round 3 applications into LHP Landscape Analysis
- Collaborate with HHAP applicants to identify high-level strategies for LHP
- Strengthen and formalize our partnerships with homeless service providers
- Continue to monitor evolving guidelines from DHCS

- The County of Orange and Orange County CoC conducted the sheltered count the night of Monday, February 21, 2022.
- The 2022 Unsheltered Count process took place over three days, Tuesday, February 22 through Thursday, February 24, to ensure the 800 square mile Orange County jurisdiction was canvassed effectively.
- The Office of Care Coordination provided the 2022 Point in Time Count Data Summary to the CoC membership, CoC Board, Commission to End Homelessness and Orange County Board of Supervisors via email and through scheduled briefings.

South:	585	Persons





Project Roomkey

- The County of Orange continues to operate temporary isolation shelters services for individuals and families experiencing homelessness who are COVID-19 sick or symptomatic
- Total capacity to serve is 100 persons
- Referrals into the program are made by the Public Health Services, hospitals, shelters, street outreach teams, and law enforcement
