# Business Calendar – Item #1

## CoC Board Nominating and Selection Process

- The Office of Care Coordination and the CoC Nominating Committee, on behalf of the Orange County CoC, have facilitated the annual CoC Board nominating and selection process.
- There are eight (8) CoC Board seats that are set to expire on December 31, 2022.
- At the November 16, 2022, meeting, the CoC Board membership approved the CoC Board Governance Charter revisions, as recommended by the CoC Nominating Committee and approved by the Policy, Procedures, and Standards (PPS) Committee.
- The approved revisions increased the CoC Board seat representatives from 17 to 19 seat representatives total, to ensure broad representation of special populations.

  - ❖ The Office of Care Coordination will work with the CoC Board to schedule a special election at a later date.

# Business Calendar – Item #1

## CoC Board Nomination and Selection Process

- On November 18, 2022, the Office of Care Coordination provided email communication with details to the CoC Board Voting Process Overview webinar
- On November 21, 2022, the CoC Board Voting Process Overview webinar provided CoC General Members details of the CoC Board nomination and election process and timeline.
- November 18, 2022, through December 2, 2022, was the nominating period inviting interested nominees to apply and complete Candidate Interest Forms.
- As Candidate Interest Forms were received, the Office of Care Coordination worked alongside the CoC Nominating Committee to schedule interviews with all applicants.
- As a new step in the CoC Board nomination and selection process, the CoC Nominating Committee facilitated interviews to review candidates' eligibility for the selected expiring seat or seat vacancy.
- Upon review of all applicants, the CoC Nominating Committee made a recommendation for selected candidates to proceed in the CoC Board Election process.
- The selected candidates were introduced to the CoC General Membership at the virtual Candidate Meet and Greet on December 12, 2022.

## Update to CalOptima Health's HMIS Data Release Request

- On September 2022, the CoC Board approved an HMIS data request from CalOptima Health to receive regular and recurring (monthly) data downloads of all persons, including adults and children, within HMIS to allow for member matching with CalOptima Health enrollment data.
- The purpose of the original request is to track housing and homelessness status of members, of which reporting on will enable CalOptima Health to obtain critical incentive funds from the California Department of Health Care Services (DHCS) that will support efforts to link persons to health and housing-related Community Supports, Enhanced Care Management (ECM) and other relevant programs and services.

# Business Calendar – Item #2

## Update to CalOptima Health's HMIS Data Release Request

- One of the cornerstones of HHIP is CalOptima Health's ability to match membership data with persons in HMIS. Now that CalOptima Health has started receiving the data and completing matches, CalOptima Health has determined that it would be beneficial to also obtain the Social Security Number (SSN) data field in addition to the original data request to improve matching.
- CalOptima Health noted that no individual level data will be shared publicly, although any resulting aggregated analyses and/or reports might be shared in the following public venues including, but not limited to, CalOptima Health's Board of Directors, Advisory Committees, and to DHCS in support of meeting HHIP metrics.
- As a MCP subject to Health Insurance Portability and Accountability Act (HIPAA) and other laws, CalOptima Health has the appropriate privacy and security mechanisms in place to ensure access to the requested data is limited, stored in a safe repository. CalOptima Health will not use these data for reasons other than those specific within the original request and is prepared to enter into a more formal Memorandum of Understanding as deemed appropriate in the future.

# Business Calendar – Item #3

## CoC Board Governance Charter

- At the November 16, 2022, meeting, the CoC Board approved the initial recommended revisions to the CoC Board Governance Charter. The CoC Board requested to amend language regarding experience requirements for the Homeless or Formerly Homeless Individual representative seat.
- Following the November 16, 2022, meeting, the Office of Care Coordination incorporated additional revisions to the CoC Board Governance Charter, as discussed and recommended by the CoC Board.
- Additionally, the Office of Care Coordination noticed a minor revision needed for the timeline of the elections and has made an update to note the election period is held in December of each year, with candidates seated in January of the new year.

# Business Calendar – Item #3

## Veterans Committee Governance Charter

- At the August 24, 2022, meeting of the Orange County CoC Board, the CoC Board approved the establishment of veterans committee focused on ending homelessness for veterans in Orange County with Eric Richardson being nominated to serve as the Veterans Committee Chair.
- Eric Richardson met with the Office of Care Coordination to create the Veterans Committee Governance Charter and finalize committee membership details, as detailed in Attachment C.

# Business Calendar – Item #3

## Veterans Committee Governance Charter

- The Veterans Committee will meet bi-monthly, every odd month, and seek to include the following representation:
  - ❖ Representative from Veterans Affairs (VA)
  - ❖ Representative from the Orange County Veteran Collaborative
  - ❖ Representative (s) from Orange County Supportive Services for Veteran Families (SSVF) service provider agencies
  - ❖ Representative from United Way Welcome Home OC Program
  - ❖ Representative (s) from Orange County housing providers and Public Housing Authorities
  - ❖ Representative from a health care agency that serves veterans at risk of homelessness or experiencing homelessness
  - ❖ Representative from an employment-focused agency that serves veterans at risk of homelessness or experiencing homelessness
- Approval of the drafted Veterans Committee Governance Charter will support the structure for the committee as regular meetings and membership are established.

## 2023 Homelessness Survey

- The Office of Care Coordination, in collaboration with the Commission to End Homelessness, will be creating a 2023 Homelessness Survey for individuals experiencing unsheltered homelessness in Orange County.
- The 2023 Homelessness Survey will seek to gather information that is not as easily captured during the biennial Point In Time Count, to gain a better understanding of the current population experiencing unsheltered homelessness.
- This survey will likely be conducted in April 2023.

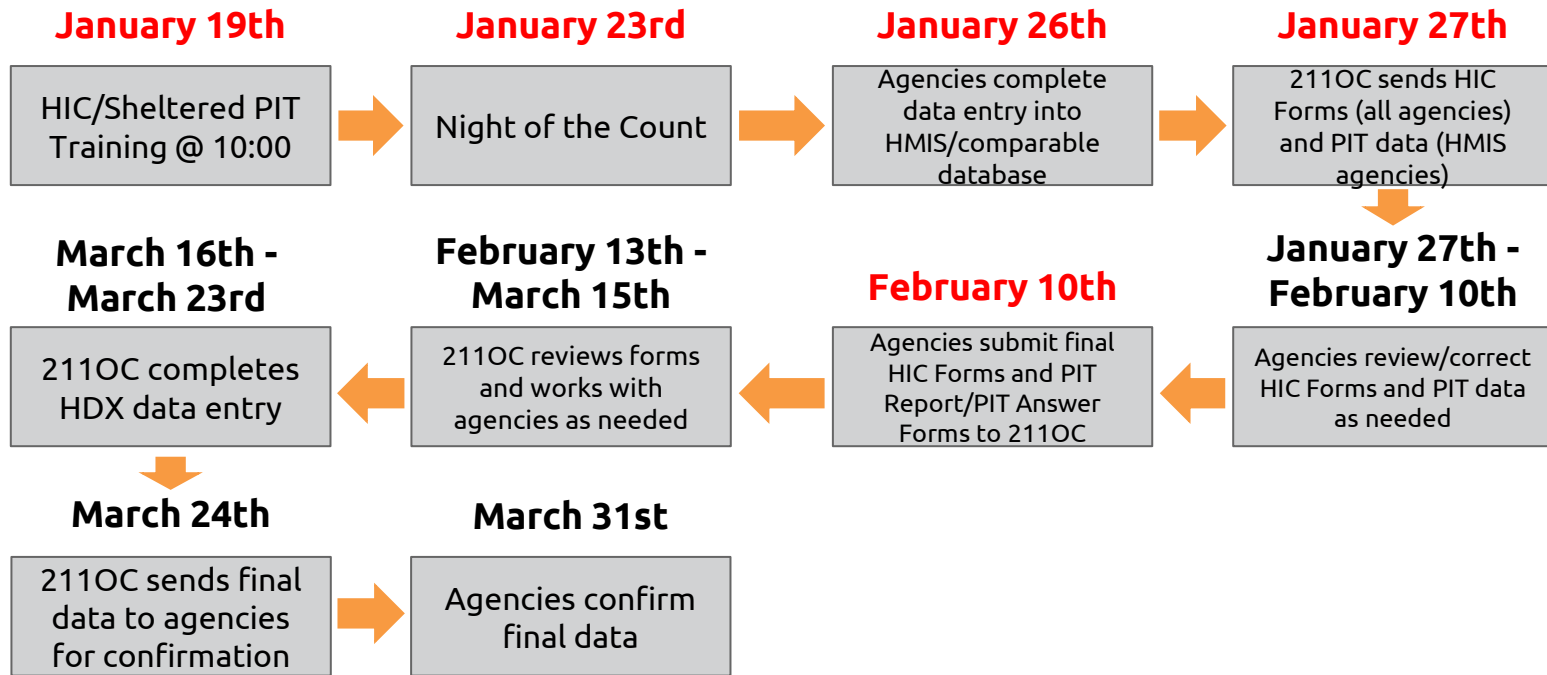

## Orange County CoC Racial Equity Roadmap Action Planning

- The Racial Equity Roadmap is grouped into five key focus areas:
  1. System Improvements
  2. Culture Shift
  3. Funding and Resource Allocation
  4. Partnerships with Adjacent Systems and Community Providers
  5. Analysis
- During the implementation planning sessions, C4 Innovations incorporated feedback received by CoC Board, Office of Care Coordination, Results Academy Team, CES Administrators, and the HMIS Lead Agency to move towards consensus around desired priorities for the Orange County CoC.
- The Office of Care Coordination plans to present on the Racial Equity Roadmap action plan and final report of recommendations received by C4 at the January 2023 CoC Board meeting.

# Business Calendar – Item #4

## Considerations for Implementation and Sustainability

- Kick off the New Year with an Equity Focus
  - ❖ The Office of Care Coordination is exploring the idea of hosting a CoC Board retreat in January to orient new and continuing CoC Board members to the Racial Equity Roadmap action plan
- Invite others to champion racial equity goals for the Orange County CoC
  - ❖ Consider planning event to invite CoC members, local stakeholders, CoC-funded agencies, people with lived experience and adjacent partners to review the prioritized goals and consider how to move the work forward.
- Racial equity is the work – not a piece of the work to occur on the sidelines.
  - ❖ Plan for integration of action planning into existing committees and CoC Board and discuss what additional infrastructure is needed, with consideration for a special committee dedicated to focusing on diversity, equity and inclusion for all impacted by homelessness in the Orange County CoC

## Centering Clients in Homeless Data Collection

- At the end of October, Department of Housing and Urban Development (HUD) announced proposed changes to the race, ethnicity, and gender identity data elements, and is inviting communities to join in the collaboration to improve the process.
- HUD will be accepting feedback through December 31, 2022. To submit feedback, use the [HUD Exchange AAQ portal](#) and select "HMIS: Homelessness Management Information System" for the "My question is related to:" prompt.
- On November 2, 2022, an informational webinar was held to support communities interested on engaging in meaningful conversations with people experiencing homelessness about the proposed changes to race, ethnicity, and gender data elements.

# Business Calendar – Item #4

## HUD 2022 Annual Homeless Assessment Report (AHAR) Part 1

- On December 19, 2022, the U.S. Department of Housing and Urban Development (HUD) released its [2022 Annual Homeless Assessment Report \(AHAR\) Part 1 to Congress](#).
- According to the report, 582,462 people were experiencing homelessness on a single night in January 2022 which has amounted to an approximate 0.3% increase in the number of people experiencing homelessness from 2020 to 2022.
- HUD releases the AHAR to Congress in two parts. Part 1 provides Point in Time (PIT) estimates, offering a snapshot of homelessness on a single night. Part 2 provides estimates of the scale of sheltered and unsheltered homelessness in the United States.

# Business Calendar – Item #4

## ALL IN: The Federal Strategic Plan to Prevent and End Homelessness

- Multi-year, interagency blueprint for a future where no one experiencing homelessness, and everyone has a safe, stable, accessible, and affordable home.
- Provides roadmap for federal action to ensure state and local communities have sufficient resources and guidance to build the effective, lasting systems required to end homelessness.
- Biden-Harris Administration have sent an ambitious interim goal to reduce homelessness by 25% by January 2025.
- Plan incorporates public input from more than 500 people who have experiencing homelessness, as well as leaders, providers, advocates, developers, and other partners from more than 600 communities, tribes, and territories, and more than 1,500 online comments and more than 80 listening sessions.
