County of Orange Social Services Agency's Pre-Release Application Processes

State



- California Department of Corrections and Rehabilitation (CDCR) completes paper Medi-Cal Single Streamlined applications within state prisons.
- CDCR is appointed as authorized representative for application purposes only
- Applications are mailed/faxed/emailed to the county 60-90 days prior to justice involved individual being released from jail
- County process pre-release applications with objective of individual being approved for Medi-Cal upon being released from prison
- New BIC mailed to prison address prior to individual being released
- Communication memo sent to CDCR regarding case disposition

County





- •CBO Project Kinship (PK), subcontractor of Community Health Initiative of Orange County (CHIOC), completes paper Medi-Cal and CalFresh Single Streamlined applications within county jails
- •PK is not appointed as authorized representative
- Currently during the Public Health Emergency (PHE), applications are completed, one on one, through the Attorney Bond window
- Applications are completed and dropped off to SSA Inmate Team up to 90 days prior to justice involved individual being released from jail
- •County process pre-release applications with the objective of individual being approved for Medi-Cal, CalFresh and General Relief upon being released from jail
- •Temporary paper cards issued on day of release. Permanent BIC cards mailed to clients.

Juvenile Hall



- The family/caretaker relative of a juvenile ward can apply for Medi-Cal prior to his/her release
- Probation staff will notify the juveniles' parents/caretaker that a Medi-Cal application will be initiated on behalf of the juvenile
- Parents have the option of opting in or out of the application process
- Probation will initiate the Medi-Cal application process by sending the Medi-Cal Application Transmittal Information referral to the county
- Once the referral is received a Medi-Cal application packet will be mailed to the parent/caretaker

Pre-Release Program

- Effective March 1, 2021, Orange County received approval from the Food and Nutrition Services (FNS) to implement a temporary waiver allowing incarcerated individuals to apply for CalFresh up to 30 days before their release date.
- Effective January 1, 2023, all counties are required to implement pre-release Medi-Cal enrollment and suspension processes (AB 133, Chapter 143)
- Implementation of pre-release processes will help ensure Medi-Cal coverage and benefits upon re-entry into the community.

Pre-Release Process and Statistics: Within 90 Days of Release

- Effective January 2023, OC Sheriff's Department (OCSD) provides a daily list of inmates to be released from County jail(s) in 90 days and less.
- List is cleared/cross referenced in CalWIN to determine case status and application requirements.
- Adult inmates and juvenile wards may apply for Medi-Cal up to 90 days prior to their release. Applications for CalFresh can only be within 30 days.
- Customers without an active cases are referred to the OCSD department who distributes an SSA flyer to notify the individual of Medi-Cal, CalFresh and General Relief.

Pre-Release Process and Statistics: Within 90 Days of Release

- Project Kinship (PK) socializes and markets the programs and encourage participation.
- Project Kinship also act as application assistors prior to release.

Suspension Release Process (Medi-Cal Only) and Statistics: Within 90 Days of Release

- When an inmate is incarcerated, Medi-Cal benefits can be suspended for up to one year.
- Upon release, Medi-Cal eligibility will be restored and temporary Medi-Cal Benefits Card can be issued to clients on day of release.

Upon Release Expansion: 30 days and less

Background:

- Prior to COVID-19, the jails reported 60,000 individuals cycling through with about 50% released in less than 30 days. Many were incarcerated for less than a week.
- OCSD provided us with a list of those inmates with less than 30 days of incarceration. SSA would reach out to discuss services for Medi-Cal and CalFresh.

Expansion:

- May 2022, SSA added a booth at the Intake and Release Center (IRC) to assist individuals upon release with Medi-Cal (MC), CalFresh (CF) and General Relief (GR) services. Two Eligibility Technicians were outstationed at the IRC.
- SSA expanded to Theo Lacy on December 12, 2022. An additional two Eligibility Technicians were deployed.
- Hours are Monday through Friday from 7 am to 12:00 PM.

Upon Release Statistics: Intake and Release Center and Theo Lacy

- Total of 474 Applications from May 2022 through January 2023.
- 90% of CalFresh, Medi-Cal and General Relief cases approved.
- Primary Reasons for Denial:
 - <u>General Relief</u>: Exhausted benefits period, residency, available resources over limits.
 - <u>CalFresh</u>: Residency, companion case receiving benefits in another county.
 - Medi-Cal: Failure to provide verifications, moved out of county/state, income limits, whereabouts unknown.

Continuing Refinement to Pre-Release Program

- Due to COVID-19 restrictions, there has been restricted access to hold workshops inside facilities. SSA is currently in lobbies.
 - Currently, SSA is only able to see inmates on a one-by-one basis by appointment through attorney bonds (behind glass).
 - Opportunities for SSA/PK conduct workshops in OCSD facility to broaden reach.
 - Explore option to allow inmates to apply online.
- Ability to store Electronic Benefit Transfer (EBT) Embosser, EBT Pin Pad Device and EBT cards onsite. Allows same day benefits card.
- Ability for SSA/PK staff to use tablets for applications and in-reach services.
- Broader data sharing. Allow SSA access to more real-time data containing length of stay and release information.
- Enhancing referral process to both SSA and partners to better connect with appropriate services.
- SSA, HCA,OCSD, CalOptima and Probation department to develop an informercial on the services and programs available to inmates upon release.
- Equipment to issue (onsite) Medi-Cal Beneficiary Identification Card (BIC) to inmates prior to release date.
