



iransitional Aged Youth (IAY) Data Trends 2020 - 2023


Inflow by Project Type

Introduction

Commercial sexual exploitation of a youth includes a range of crimes and activities involving the sexual abuse or exploitation of a child for the financial benefit of any person or in exchange for anything of value, including monetary and nonmonetary benefits.

While any child could become a victim, certain factors contribute to a child being at higher risk of commercial sexual exploitation and/sex trafficking. Children who have a history of abuse or neglect, especially sexual abuse, and youth involved in the foster care system are particularly vulnerable.

Purpose of this guide:

This resource guide is to assist caretakers in Orange County in navigating the unique needs and services for victims of commercial sexual exploitation and sex trafficking, commonly referred to as Commercially Sexually Exploited Children, or CSEC. In June 2014, Senate Bill 855 clarified that children who are victims of exploitation will be served by the child welfare system, which is designed to protect and serve abused and neglected youth. If you are concerned a child in your care is a victim, there are resources in the community to help. If a child in your care is at imminent risk for sexual exploitation, please contact local law enforcement and the Orange County Child Abuse Hotline at 714-940-1000 or 800-207-4464.

If a youth in your care

- Goes missing from care or runs away.
- Has new items (jewlery, clothing, purses, phones, etc.) and you don't know where they came from.
- Is involed with an older man or woman.
- Being secretive about what they are doing online.

You can support the youth by:

- Asking non-judgmental questions:
 Neither you nor the child is to blame.
- Being patient: Don't push a youth to talk before they are ready. Believe what they say when they do begin to talk.
- Seeking support: The resources in this guide are here to support you and the youth in your care.

Terms

You may encounter the following terms as you and the youth in your care receive services and support.

Child Abuse Services Team (CAST): Coordinated on-site services that enable social services, law enforcement, deputy district attorneys, medical providers and therapists to collaborate on investigations. A child may be referred to CAST via law enforcement or their assigned social worker.

California Department of Social Services (CDSS): Responsible for the oversight and administration of programs serving California's most vulnerable residents.

Children & Family Services (CFS): A division in the County of Orange Social Services Agency designed to protect children from abuse and neglect, providing services to at-risk families.

Court Appointed Special Advocates (CASA): Volunteers who mentor children in foster care, advocating their best interests in the courtroom and other settings. A child may receive a CASA by way of a juvenile court order.

Extended Foster Care (EFC): Allows eligible youth in the child welfare and probation systems to remain in foster care until age 21. Youth may leave extended foster care and later choose to re-enter the program up to age 21.

Foster Family Agency (FFA): Organized and operated on a nonprofit basis and engaged in the following activities: recruiting, certifying and training resource parents, providing professional support to resource parents, and finding homes or other temporary or permanent placements for children who require more intensive care.

Institution for Mental Disease (IMD): A hospital, nursing facility or other institution of more than 16 beds that is primarily engaged in providing diagnosis, treatment or care of persons with mental diseases, including medical attention, nursing care and related services.

Intensive Services Foster Care (ISFC): For children and youth requiring in-depth treatment and behavioral supports, and/or who have special healthcare needs, while helping them remain in a home-based family setting.

Kin-Gap: Serves children leaving the foster care system and entering into guardianship with a relative.

Legal guardian: Adult legally responsible for the needs of a minor/youth appointed by the court. Responsible for the child's daily care and control.

Non-Minor Dependents (NMDs): A current dependent or ward of the Juvenile Court who satisfies all of the following criteria:

Has reached 18 years of age while under an order of foster care placement, but is less than 21

- years of age
- Is in foster care under the placement and care responsibility of Children & Family Services (CFS), OC Probation or an Indian tribe that entered into an agreement pursuant to Welfare and Institutions Code (WIC) Section (§) 10553.1
- Is participating in or intending/willing to participate in a Transitional Independent Living Plan (TILP)
- Youths who voluntarily remain in foster care after the age of 18 until 21.

Orangewood Children and Family Center (OCFC): 24-hour emergency shelter care facility, operated and owned by the County of Orange Social Services Agency for children who have been abused, abandoned and/or neglected. OCFC is licensed by the California Department of Social Services as a temporary shelter care facility.

Protective custody warrant: A court order authorizing the removal of a child from the physical custody of the parent/guardian and it is considered the first order pertaining to the removal of the child from the home.

Relative: An adult who is related to the child by blood, adoption or affinity within the fifth degree of kinship, including stepparents, stepsiblings and all relatives whose status is preceded by the word "great" or the spouse of any of these persons, even if the marriage was terminated by death or dissolution.

Resource Family Approval (RFA): Caregiver approval process that combines elements of the foster parent licensing, relative approval and approvals for adoption and guardianship processes. Once approved, a caregiver is eligible to have children in foster care placed in their home.

Senior Social Worker (SSW): Social worker with the County of Orange Social Services Agency's Children & Family Services. Several SSWs will be involved with the child, caretaker and family when involved with the Juvenile Court.

Short Term Residential Therapeutic Program (STRTP): A 24-hour residential facility operated by a public agency or private organization that provides specialized care, support, supervision and treatment to children and non-minor dependents.

County of Orange Social Services Agency (SSA): Operates under the policy direction of the Orange County Board of Supervisors and the California departments of Social Services and Health Care Services and is responsible for planning, implementing and operating many of the social services programs provided by the County of Orange, including the Children & Family Services (CFS) division.

Transitional Housing Placement Program (THPP): Placement opportunity for youth ages 16-18 years old. THPP helps participants emancipate successfully by providing a safe environment to learn skills that can make them self-sufficient.

Wraparound: A system of care where care coordinators and family partners work with eligible children ages 5-17 and their families on goals to help them be successful.


