Inflow vs. Outflow by Month




Currently, there are 274 veterans on the Veteran Registry including 260 veterans experiencing homelessness. In the previous 12 months, 212 veterans have been housed in permanent, stable housing. Over 30 agencies, including the VA Community Resource and Referral Center, outreach providers, and shelter providers, continue to meet weekly to coordinate housing and services for veterans experiencing homelessness in Orange County. In the past 12 months, there has been a 19% increase in the number of veterans experiencing homelesness in Orange County.





- 260 veterans are known to be experiencing homelessness in OC with most veterans experiencing homelessness in Central SPA (55%).
- The average age of veterans on the Veteran Registry is 52 years old.
- The average household size is 1.3 people.
- 8% of the veteran households include minor children.

- 60% of the veterans experiencing homelessness in Orange County are currently unsheltered.
- 53% of the veterans in Orange County are experiencing chronic homelessness.
- The median length of homelessness is 1 year and 4 months and the average length of homelessness is 3 years.
- 77% of veterans on the Veteran Registry have a disabling condition, including 55% reporting a mental health disability.
- 158 veterans are working on applying for HUD-VASH.
- 28 veterans are interested in being housed through SSVF or referred to a GPD program.

#### **Next Steps for Data Reviewed**

- Key Observations of Population of Focused Client Groups
  - ❖ 76 clients are 62 years or older
  - 22 families, households with at least one minor child
  - 18 clients have experience 10 or more years of homelessness
- Targeted Outreach
  - Veteran service providers are focusing on targeted outreach to veterans:
    - Retrieving veteran details from CES Veteran Registry by-name list (BNL) through communication with relevant provider
    - Mapping of last known locations in North, Central and South Service Planning Areas (SPAs)
    - Outreach coordinated by SSVF, VA, and veteran's current provider. Other providers to involve?
    - Teams from VOALA and PATH to attend with access to emergency accommodation
    - Conduct a needs assessment to understand needs related to health, benefits and links to other services
    - Obtain ongoing support from providers needed
    - Review progress at the next committee meeting

#### **Training Ideas for Veteran Engagement**

- At the March 16, 2023, meeting of the Veterans Committee, the membership and attendees discussed a potential need for designing training for veteran service provisions
- Specifically, trainings related to outreach strategies and best practices related to intake assessments were discussed
