<u>Purpose:</u> The TAY Collaborative Committee will function as an advisory group to the CoC Board and will support the CoC Board in recommending policy, establishing best practices, and providing feedback to create a youth homeless response system to prevent and end youth homelessness. The TAY Collaborative Committee will ensure housing interventions for Orange County's youth address stable housing, permanent connections, education, employment, and well-being so Orange County's most vulnerable youth and young adults can enjoy a healthy transition to adulthood.

- 1. **Youth Action Board Recruitment –** Dr. Shauntina Sorrells, Chief Program Officer, Orangewood Foundation
 - a. There have been about 3-5 members of the Youth Action Board (YAB) in the last 6 months.
 - b. Due to time constraints, the YAB members have been having issues joining the TAY Committee.
 - c. The YAB is currently recruiting two additional members. Members are currently compensated \$80 an hour for attending YAB meeting and Continuum of Care (CoC) meetings.
 - d. United Way will be providing funding to the YAB through the end of the year.
 - e. The YAB is working on establishing some recommendations for best practices for TAY shelters, in collaboration with Covenant House.
 - f. An attendee of this meeting, Euronymous, expressed interest in joining the YAB.
- 2-1-1 Orange County Resource Training Talia Rodriguez, Resource Supervisor, 2-1-1 Orange County
 - During the Youth Homeless Demonstration Program (YHDP) application process, it was observed that there were many providers that were not sure where to access TAY resources.

- b. 2-1-1 Orange County's (2110C) mission is to connect Orange County's most vulnerable with health and human services.
- c. The 2-1-1 resource database is composed of nonprofit organizations, government agencies, and free/low-cost services.
- d. The resource database contains information of over 1,100 organizations, providing over 3,000 programs in Orange County. These resources are updated, at least annually.

- f. The 2-1-1 call center can provide resources in English, Spanish, Farsi, and Vietnamese. In addition to this, Information and Referral Specialists can connect to a language line at no cost.
- g. Dr. Shauntina asked Talia if it was possible to add a TAY Resource Portal, similarly like the Teen, Military/ Veteran portals. Talia will discuss this idea with their Program Manager and provide an update.

- 3. **Transitional Age Youth (TAY) Dashboard –** Mayra Vargas, Coordinated Entry System Staff Specialist, Office of Care Coordination
 - a. As of September 2023, the TAY Registry reflected the following datapoints:
 - i. There were 14 self-identified chronically homeless TAY.
 - 1. This is a vast difference from the beginning of this year. This number has been steadily decreasing because of on-going training and clarification around what chronically homeless is defined as.
 - ii. There was a total of 4 verified chronically homeless TAY and 9 TAY with a verified disabling condition.
 - iii. For this current fiscal year (July 1, 2023 September 1, 2023), there have been 10 TAY that have been housed, which totaled 10 participants within those households.
 - iv. There are currently a total of 231 TAY active in the Coordinated Entry System (CES) project.
 - 1. On queue 141
 - 2. Not on queue 66
 - 3. Enrolled 16
 - 4. Matched 8
 - v. Housing Interest indicated that 85 TAY believe their episode of homelessness would be resolved with Rapid Rehousing, and 56 opted for Permanent Supportive Housing or Other Permanent Supportive Housing.
 - vi. Inflow into CES continues to outpace the outflow.
- 4. Continuum of Care (CoC) Updates Sarah Jones, CoC Manager, Office of Care Coordination
 - a. General CoC Updates
 - i. FY 2024 HMIS Data Standards Updates
 - HUD has released updates to the Fiscal Year (FY) 2024 Homeless Management Information System (HMIS) Data Standards, which includes the updates to the Coordinated Entry System data collection requirements announced on July 10, 2023.
 - 2. The FY 2024 HMIS Data Standards provide the requirements for the programming and use of all HMIS and comparable database systems and goes into effect October 1, 2023.

- ii. Training Opportunity: National Standards for the Physical Inspection of Real Estate (NSPIRE)
 - 1. The Office of Care Coordination will be hosting a training on the National Standards for the Physical Inspection of Real Estate (NSPIRE).
