COMMISSIONER COMMENTS

Commissioner Rose – Oral re: City of Lake Forest will celebrate the Grand Opening of Mountainview Apartment Homes, which will provide 72 units of affordable housing, on March 1st.

Commissioner Spitzer – Oral re: Directed staff to study how the County of Orange could assume costs or allow funding flexibility for cold weather emergency shelter programs in order to reduce partner costs, incentivize partnerships and expedite annual planning; requested an Ad-Hoc comprised of the Commissioners representing each Service Planning Area is established to discuss and advise on cold weather emergency shelter programs and provide recommendations to the full Commission at the April 17th meeting.

Commissioner Cornwall – Oral re: Announced she will be leaving Providence Health Systems and will be employed by the City of Irvine as the Assistant Chief of Health and Wellbeing beginning in March.

Chairman Sarmiento – Oral re: Expressed appreciation to everyone for comments and questions and agreed on need to get ahead of cold weather in 2024 and other potential extreme weather events.

2024 Point In Time Count

- Thank you to all volunteers.
- Over 1,100 volunteers collectively contributed more than 4,000 hours of service, with 392 volunteers in the North Service Planning Area (SPA), 435 volunteers in the Central SPA, and 273 volunteers in the South SPA.
- Volunteers assembled over 6,000 hygiene kits and snack packs.
- A special thank you to Cal Optima Health and Orange County United Way for their donations.
- The Office of Care Coordination expects the 2024 Point In Time Count results in early May.

Cold Weather Emergency Shelter Program

- On December 13, 2023, the Commission to End Homelessness directed the Office of Care
 Coordination to negotiate with the City of Anaheim for a Cold Weather Emergency Shelter Program.
- On January 23, 2024, a Memorandum of Understanding (MOU) was established between the City of Anaheim (City) and the County of Orange (County) for the City to provide up to 50 emergency shelter beds during cold and inclement weather for individuals experiencing homelessness from February 1, 2024, through April 15, 2024.
 - The City's Cold Weather Emergency Shelter Program will be activated based upon inclement and cold weather events and will contract with faith-based and/or community-based organizations.

Tiny Homes Ad Hoc

- The first meeting was held on January 17, 2024.
- Through site visits, interviews and studying best practices, the Tiny Homes Ad Hoc seeks to provide the Commission to End Homelessness with the following:
 - Universal framework to evaluate different tiny homes models.
 - Identification of potential funding resources.
 - Recommendations for possible, viable models for Orange County.

PRESENTATION – ITEM #2 HHAP OVERVIEW

- HHAP Round I (first available in 2019) \$650 million grant that provides local jurisdictions with funds
 to support regional coordination and expand or develop local capacity to address their immediate
 homelessness challenges.
- HHAP Round 2 \$300 million grant that provides support to local jurisdictions to continue to build on regional collaboration developed through previous rounds of Cal ICH funding and to develop a unified regional response to homelessness.
- HHAP Round 3 \$1 billion grant that provides local jurisdictions, including federally recognized tribal governments, with flexible funding to continue efforts to end and prevent homelessness in their communities.
- HHAP Round 4 \$1 billion grant that provides local jurisdictions, including federally recognized tribal governments, with flexible funding to continue efforts to end and prevent homelessness in their communities.

PRESENTATION – ITEM #2 HHAP FUNDING ACCOMPLISHMENTS

Round I – Yale Navigation Center

- HHAP-I funds supported the construction and capital improvements of the Yale Navigation Center.
- Yale opened in January 2021 and operates as an emergency shelter and full-service navigation center for individuals experiencing homelessness in the Central Service Planning Area

Round 2 – Homekey Programs

- HHAP-2 funds supported the operations for Homekey Program units during the interim housing phase.
- 132 units in the North Service Planning Area and 62 units in the Central Service Planning Area, serving individuals and adult only households experiencing homelessness

Round 3 – Regional Care Coordination Services

- HHAP-3 funds support services that help respond to and address unsheltered homeless conditions and provide comprehensive care coordination to individuals experiencing homelessness in the North, Central and South Service Planning Areas.
- Providers coordinate and collaborate with other components of the Orange County System of Care.

PRESENTATION – ITEM #2 HHAP-5 FUNDING REQUIREMENTS

- Regions must apply together and submit a single Regionally Coordinated Homelessness Action Plan
 - The Orange County region includes the County of Orange, Orange County CoC, City of Anaheim, City of Santa Ana and City of Irvine
 - Regions must have a Memorandum of Understanding committing to participation in and to comply with the Regionally Coordinated Homelessness Action Plan
- Administrative costs are capped at 7 percent of each allocation
- Youth Set-Aside Requirement
 - At least 10 percent of allocation must be for services for homeless youth
- Community Engagement
 - Regions are required to hold at least three public meetings with stakeholders before the completion of the Regionally Coordinated Homelessness Action Plan

PRESENTATION – ITEM #2 REGIONALLY COORDINATED HOMELESSNESS ACTION PLAN

- I. Identifies participating jurisdictions' roles and responsibilities pertaining to outreach and site coordination, siting and use of available land, development of interim and permanent housing options, coordination and connection to service delivery.
- 2. Identifies system performance measures and describes key actions to improve each measure.
- 3. Describes key actions the region will take to ensure racial and gender equity in service delivery, housing placements, housing retention, and changes to procurement to affirm equitable access to service for groups overrepresented amount those experiencing homelessness.
- 4. Describes the collaborative efforts to address how people served through place-based encampment resolution projects will be included in prioritization for permanent housing within Coordinated Entry System.
- 5. Describes participating jurisdictions' actions to reduce homelessness among individuals exiting institutional settings including jails, prisons, hospitals, etc.
- 6. Includes the total amount of available funding, amount prioritized for permanent housing solutions, and explanations of how each participating jurisdiction is utilizing local, state, and federal funding programs to end homelessness.
- 7. Explains how the region is connecting individuals to wrap-around services from all eligible federal, state, and local benefit programs.

PRESENTATION – ITEM #2 HHAP-5 ELIGIBLE USE ACTIVITIES

- The overarching objective of HHAP funds is to effectively address and end people's experiences of homelessness
- HHAP-5 statute organizes Eligible Use Categories into three conceptual groups:
 - Permanent Housing
 - Interim Housing
 - Services and Systems Support

PRESENTATION – ITEM #2 ELIGIBLE USES - PERMANENT HOUSING

Eligible Use Categories	Explanation	
Delivery of Permanent Housing and Innovative Housing Solutions	Costs support the provision of permanent housing.	
Rapid Rehousing	Costs support operating a rapid rehousing type housing service. This means a tenant-based, time limited, permanent housing program, inclusive of wrap-around services.	
Prevention and Shelter Diversion	Costs support eligible populations access safe alternatives to shelter and/or remain safely housed at their current residence.	
Operating Subsidies – Permanent Housing	Costs support operations in new and existing affordable or supportive housing units serving people experiencing homelessness. May include operating reserves.	

PRESENTATION – ITEM #2 ELIGIBLE USES – INTERIM HOUSING

Eligible Use Categories	Explanation
Operating Subsidies – Interim Housing	Costs support operations in interim housing serving people experiencing homelessness. May include operating reserves.
Interim Housing	Costs support the provision of interim housing. May not be used to fund new interim housing solutions without written permission from Cal ICH. This does not apply to new interim housing solutions for youth.
Improvements to Existing Interim Housing	Costs support renovation of existing interim housing to improve the quality of the life for people experiencing homelessness who are residing in the interim housing.

PRESENTATION – ITEM #2 ELIGIBLE USES – SERVICE PROVISION AND SYSTEMS SUPPORT

Eligible Use Category	Explanation
Street Outreach	Costs support Outreach programs.
Services Coordination	Costs support wrap-around services not directly provided through another project.
Systems Support	Costs support homelessness services system infrastructure, regional coordination, and/or improves accessibility and outcomes generally, as opposed to specific clients.

CalOptima Health Overview

- Mission: To serve member health with excellence and dignity, respecting the value and needs of each person
- Founded as Orange County's community health plan for lowincome families, seniors and people with disabilities
- Serves 970,000 members: 1 in 4 adults and 1 in 3 children in Orange County
- Has 1,500 employees and an annual budget of \$4 billion





What is CalAIM?

- CalAIM develops the framework to address the social determinants of health and improve health equity
- CalAIM is moving Medi-Cal toward a population health approach
- Recognizes that a individuals ability to be healthy is 80% dictated by things outside of the hospitals and health care settings

CalAIM: Services

Recuperative Care

Short-Term (90 days)
residential care for individuals
who no longer require
hospitalization, but still need to
heal from an injury or illness.

Includes interim housing, meals, ongoing monitoring of medical or behavioral health conditions. Monitoring includes vital signs, assessments wound care, medication)

Includes coordination of transportation to medical appointments, connection on on-going services, support in accessing housing.

Housing Transition Navigation

Assists with identifying and securing housing and includes tenant screening, developing a housing plan, benefits advocacy, and landlord engagement.

Housing Deposits

Assist with securing and funding onetime services necessary to establish a basic household that do not include room and board

Housing Tenancy and Sustaining Services

Provides ongoing case management to maintain safe and stable tenancy once housing is secured.

Short-Term Post-Hospitalization Housing

Provides members who do not have a residence and who have high medical or behavioral health needs to continue recovery immediately after exiting a facility

Day Habilitation Programs

Provides members with assistance in acquiring, retaining and improving the skills necessary to reside successfully at home and in their community
