- b. <u>IRC Lobby Activity</u>: Probation, Social Services Agency, and Project Kinship provided an overview of their staff and services offered to individuals exiting through OCSD's Intake and Release Center.
- c. OCSD BH Bureau: OCSD provided an update on their Behavioral Health Bureau and recent expansion including current challenges and recent successes.
- d. <u>CARE Act</u>: Public Defender, Health Care Agency, and Courts updated the Committee on the implementation and status including process challenges and
