Nishtha Mohendra motioned to approve items 1 and 2 on the Consent Calendar. Mark Lee seconded the motion. Maricela Rios-Faust, Brateil Aghasi, Patience Biosah, Barbara Burke, Mark Lee, Nishtha Mohendra, Lydia Nationalesta, Wendy Seiden, Tianna Terry, Katherine Tan, and Sharon Wie voted yes. Motion passed.

BUSINESS CALENDAR

1. CES for Survivors Update – Sarah Jones, Continuum of Care (CoC) Manager, Office of Care Coordination

Sarah Jones provided background on the review and approval process timeline for the CES Policies and Procedures, as well as the updates made to the CES Policies and Procedures. The Office of Care Coordination as the CES Lead began implementing CES Policies and Procedures updates on January 1, 2024, including CES Partner training. At this time, current challenges of implementation of CES for Survivors are that victim service providers are reporting that housing funds have largely been exhausted for the current program year and survivor dedicated housing resources are extremely limited.

Committee Discussion:

- Chair Maricela Rios-Faust asked questions regarding how if a households may be served through the different components of CES – Individuals, Families and Survivors. Chair Maricela Rios-Faust inquired on the process for monitoring and evaluating the implementation of CES for Survivors. Chair Maricela Rios-Faust shared that there is currently no funding in the CoC to provide hotel vouchers and explained that many victim service providers will soon experience an approximate 50% reduction in federal and state funding which will impact the system of care for DV survivors.
- Tianna Terry provided context on how CES for Survivors works and clarified that individuals would not lose their status on the community queue, nor would anyone get pushed down based on DV prioritization.
- Nishtha Mohendra explained that when CES for Veterans was implemented, there were unforeseen gaps and inquired if the lessons learned from CES for Veterans were considered and addressed for CES for Survivors implementation.
- Sharon Wie asked if there are any discussions taking place with the other components of CES to adjust prioritization.
- Mark Lee explained that their understanding is that victim service provider access points would conduct prioritization for DV survivors, but the survivor would not be automatically added to the other components of CES.
- Lydia Nationalesta explained that when working with DV survivors, there are many times
 of shelter beds not being available, and the DV survivor will ultimately go back and live
 with the perpetrator. Lydia Nationalesta inquired if there would be funding in the future
 to place survivors into a hotel while identifying permanent housing.

2. University of California, San Francisco (UCSF) Benioff Homelessness and Housing Initiative (BHHI) intimate partner violence (IPV) and homelessness findings — Maricela Rios-Faust, Chair

In January 2024, the UCSF BHHI released a report on the relationship between IPV and homelessness in California. The analysis is based on survey data and in-depth interviews from the California Statewide Study of People Experiencing Homelessness (CASPEH). From the report, there were seven (7) findings and BHHI endorsed policy recommendations in four key areas: promote policies and programs that center violence and homelessness prevention; promote equity in responses to intimate partner violence; increase access to affordable, permanent housing options for survivors; and increase support for survivors currently experiencing homelessness.

Committee Discussion:

- Lydia Nationalista stated that their experience resonated with the report. Lydia Nationalista shared that their former college assisted with resources and emphasized that the lack of resources makes it difficult for survivors to leave IPV situations.
- Sharon Wie commented that it would be important to share BHHI policy recommendations with the CoC Board and encourage the CoC to update current CoC resources in order to shape future resources.
- Nishtha Mohendra shared that some of the findings are not exclusive to the experience of DV survivors and are applicable across the homeless service system.
- Wendy Seiden agreed with Sharon Wie's comments and noted that some of the <u>webinars</u> that UCSF should be shared with the CoC. Wendy Seiden also emphasized that prevention needs to be highlighted and needs to be part of the DV homelessness work. Wendy Seiden stated that services such as bus passes, childcare, and other case management services need to be part of services provided.
- Barbara Burke emphasized the policy recommendation of "promote equity in responses" because it is a good example as to why DV survivors and other individuals are part of the DV Committee and should be included in meetings. Barbara Burke stated that flexible schedules, remote options, etc. are a good way to promote equity.
- Mark Lee noted that it was interesting to see that only 5% of people experiencing IPV
 were staying in DV shelters. Mark Lee stated that DV shelter programs need to have
 equitable access to CES services, and the CoC needs additional resources. Mark Lee noted
 the importance for the Orange County CoC to understand that additional resources are
 needed to bridge the gap of victim service provider services.
- Chair Maricela-Rios Faust emphasized the importance of funding DV resources, flexible funding, preventing people from being re-victimized, and being open to reflect on the DV process. Chair Maricela-Rios Faust stated that not every survivor will come through CES for Survivors.

3. Brown Act Update – Sarah Jones, CoC Manager, Office of Care Coordination

Sarah Jones shared that the Office of Care Coordination received legal counsel and guidance that all CoC Committee meetings are to transition from virtual to being held in person, as the COVID-19 State of Emergency has ended and impacted allowance of continued teleconferencing without just cause and emergency circumstances. Moving forward, CoC Committee meetings will be held

in-person while the Office of Care Coordination continues exploring additional opportunities for increased engagement.

Public Comments:

- Marisol Johnson, a representative from Dayle McIntosh Center, and shared requested accommodation for other CoC meetings because their organization works with people with disabilities and in their organization still follows COVID-19 prevention protocol which impacts when staff can go to on-site meetings. Marisol Johnson encouraged virtual meetings to consider people who have disabilities.
- Francesca Cappellini agreed that having teleconferencing is much more equitable for the DV population, regardless of what the law states.

Committee Discussion:

- Katherine Tan stated that a lot of the DV Committee members do not have the privilege
 to take time off from work and the transition to in-person meetings will impact
 participation. Katherine Tan asked who the County Counsel representatives are and
 stated a preference to do research of their own.
- Sharon Wie asked if there is an entity that the DV Committee could directly voice concerns
 to in Orange County about how in-person meetings would exclude some of the survivors
 who serve on the DV Committee. Sharon Wie explained personal experience of serving
 in committees in other communities and those communities continue to meet virtually.
- Barbara Burke stated that they are a DV survivor representative of the African American community and emphasized on the importance of meeting virtually. Barbara Burke asked CoC staff to check with the UJIMA program in Washington as they dealt with the issue of meeting in-person and the UJIMA programs understands that virtual meetings is an equity issue while having the support of the government. Barbara Burke stated that the DV Committee will not have participation from homeless people, DV survivors or people of color to any great extend if flexibility and virtual participation is not allowed.
- Chair Maricela Rios-Faust committed to continued advocacy for access when other stakeholders do not.

BUSINESS CALENDAR

1. CES for Survivors Update – Sarah Jones, CoC Manager, Office of Care Coordination

Sarah Jones presented on the CES for Survivors update. The Office of Care Coordination initiated CES for Survivors on January 1, 2024, enabling CES access points and Orange County United Way 2-1-1 Orange County's (2110C) Virtual Front Door to identify survivors of domestic violence and sexual assault and facilitate a warm handoff to victim service providers (VSPs). In January, the Office of Care Coordination commenced training CES partners, in partnership with VSPs, on survivor identification using the Pre-Assessment tool and process of referring survivors to CES for Survivors. As of February 2024, VSP partners can refer survivors to both CES for Survivor-specific housing resources and the general CES Community Queue, while ensuring complete anonymity.

Committee Discussion:

- Chair Maricela Rios-Faust inquired about the committee's preferences for assessing the
 functionality of the system and identifying necessary changes. Chair Maricela Rios-Faust
 highlighted the opportunity to gain insight into survivors' experiences with the screening process
 across different systems. Chair Maricela Rios-Faust also emphasized the importance of examining
 data regarding the effectiveness of the process for survivors.
- Mark Lee inquired about whether CES can offer clarification on the role of VSPs not funded by the CoC in the referral process. Mark Lee has requested the committee to review the program placement of survivors in CES and assess if any improvements are required in the Policies and Procedures to ensure equitable access for survivors to both CES survivor-specific and nonsurvivor-specific programs.
- Nishtha Mohendra inquired about the ramp-up experience for CES for survivors' program implementation.
- 2. Funding Updates Sarah Jones, CoC Manager, Office of Care Coordination and Maricela Rios-Faust, Chair
 - a. Overview of CoC and State funding updates as it relates to addressing the needs of domestic violence survivors in Orange County

Chair Maricela Rios-Faust provided background on the funding update. At the February 20, 2024, meeting, the DV Committee discussed the challenges faced by survivors due to limited housing resources and reviewed policy recommendations from the University of California, San Francisco Benioff Homelessness

and Housing Initiative report, emphasizing the need to promote policies and programs for violence and homelessness prevention, equity in responses to intimate partner violence, and increased access to affordable permanent housing options for survivors. The Victims of Crime Act (VOCA) funding, crucial for supporting crime victims' needs, including housing services, counseling, and crisis response, faced budget cuts, affecting organizations across California. In Fiscal Year (FY) 23-24, California's crime victim services will receive \$87 million, a 43% reduction from FY 23.

Sarah Jones presented on the Homeless Housing, Assistance and Prevention (HHAP) Program. The HHAP Program, administered by the State's Business, Consumer Services and Housing Agency (BCSH) through the California Interagency Council on Homelessness (Cal ICH), provides funds to local jurisdictions to address homelessness. At the February 28, 2024, CoC Board meeting, the Office of Care Coordination presented the HHAP Round 5 Notice of Funding Availability (NOFA) application. Feedback and recommendations were invited from CoC Board members and the public until March 8, 2024. Following a meeting with CoC Board Officers on March 13, 2024, it was recommended to allocate funds to special populations, allowing flexibility. On March 27, 2024, the CoC Board approved the establishment of a HHAP Program ad hoc to support the planning and programming of HHAP Program Rounds 1-4 remaining funds. Sarah Jones also presented on the CoC Program Notice of Funding Opportunity (NOFO). The U.S. Department of Housing and Urban Development (HUD) annually releases a Notice of Funding Opportunity (NOFO) for Continuums of Care (CoCs) to apply for competitive funding. The FY 2024 CoC Program competition is expected to have a timeline similar to that of FY 2023. At the National Alliance to End Homelessness (NAEH) conference, HUD's Office of Special Needs Assistance Programs (SNAPS) announced that Domestic Violence (DV) Bonus funds will be available for the FY 2024 CoC Program competition.

Chair Maricela Rios-Faust also noted the VOCA budget cuts are affecting the ability of VSPs to meet the needs of domestic violence survivors and their families in Orange County. Chair Maricela Rios-Faust noted it is crucial for VSPs to have access to funding for various housing options and for service providers to have sufficient staffing to screen and connect survivors to housing. Chair Maricela Rios-Faust noted urgent advocacy is needed to address the funding gaps caused by the VOCA budget cuts for survivors of domestic violence, dating violence, sexual assault, and stalking.

Committee Discussion:

- Nishtha Mohendra proposed presenting a recommendation to the CoC board to pursue specific
 unexplored funds as a beneficial strategy. Nishtha Mohendra inquired about the potential for the
 CES for Survivors to collaborate with external service providers to monitor the receipt of resources
 by survivors. Nishtha Mohendra inquired about the possibility of partnering with CalOptima and
 leveraging the CalAIM program to support survivors. Nishtha Mohendra suggested a partnership
 with the Housing Opportunities Committee to inquire about developers interested in housing
 specifically for survivors of domestic violence.
- Mark Lee expressed contentment with the recent allocation of funds for survivors from the CoC for housing-specific programs and inquired about the possibility of exploring funding for other necessary program areas beyond Rapid Rehousing programs. Mark Lee inquired about how CES can be helpful in connecting survivors to housing opportunities.
- 3. CoC Updates Sarah Jones, CoC Manager, Office of Care Coordination

Sarah Jones presented the following CoC updates:

Development and Operations of a People with Lived Experience of Homelessness Financial Compensation Coordination Program Request for Information (RFI):

The Office of Care Coordination, as the Collaborative Applicant and Administrative Entity of the Orange County CoC, has released an RFI for a Development and Operations of a People with Lived Experience of Homelessness Financial Compensation Coordination Program. The RFI may lead to a partnership with one or more respondents for the requested program activities. Development and Operations of a People with Lived Experience of Homelessness Financial Compensation Coordination Program RFI is available on OpenGov Procurement and proposals must be submitted by a revised deadline of April 26, 2024, at 2:00 p.m. Pacific Time (PT).

County Procurement Office Supplier Outreach:

The County Procurement Office invites all interested vendors and service providers to the annual Supplier Outreach Day. The event aims to educate attendees on County of Orange procurement and contracting processes and improve partnerships to better serve the community.

Anti-Trafficking Housing Solicitation Applications Now Being Accepted:

The Office of Victims of Crime (OVC), a part of the U.S. Department of Justice (DOJ), is currently seeking applications for the FY2024 Anti Trafficking Housing Assistance Program. The program's objective is to strengthen organizations in order to offer housing and related services to victims of human trafficking. Eligible applicants include state and city governments, public institutions of higher education, county governments, public housing authorities, Native American tribal organizations, and qualified nonprofit organizations.

2024 Violence Against Women Act (VAWA) and Survivor Housing Community Conversations:

HUD will host a series of community conversations focusing on implementing VAWA and survivor-centered housing at the system, project, and human levels. Each conversation will feature a diverse panel of system leaders, project staff, and individuals with lived experiences from both the homelessness response and victim services worlds.

1. CES for Survivors Update – Sarah Jones, CoC Manager, Office of Care Coordination

Sarah Jones presented an update on the CES for Survivors. On May 9, 2024, the Office of Care Coordination released the Coordinator for CES for Survivors Request for Proposals (RFP). Through this RFP, the Office of Care Coordination was seeking proposals from qualified organizations to serve as the Coordinator for the CES for Survivors for all three Service Planning Areas (SPA) North, Central, and South in Orange County. On May 30, 2024, the RFP for the Coordinator for CES for Survivors closed. Currently, the Office of Care Coordination is working on next steps of the RFP process.

Committee Discussion:

- Wendy Seiden inquired about the collaboration between the Office of Car Coordination and the coordinator for CES for Survivors.
- Tiana Terry asked if CES for Survivors would operate similarly to the current CES.
- Chair Maricela Rios-Faust inquired about the current procedures in place for the CES for Survivors.

- **2. Orange County 2024 Point In Time Count** Sarah Jones, CoC Manager, Office of Care Coordination and Maricela Rios-Faust, Chair
 - a. Review 2024 Point In Time data related to domestic violence subpopulation in Orange County

Sarah Jones presented on the data from the Orange County 2024 Point In Time (PIT) Count. The County of Orange in partnership with the Orange County CoC conducted the sheltered count the night of Monday, January 22, 2024. The unsheltered count process took place over three days, Tuesday, January 23, 2024, through January 25, 2024. The 2024 PIT Count data showed that 10.01% of unsheltered adults identified as experiencing domestic violence and 10.40% of sheltered adults identified as experiencing domestic violence. In comparison to the 2022 PIT Count, the domestic violence subpopulation increased by 30.87% in the 2024 PIT Count. Committee Discussion:

- Chair Maricela Rios-Faust stated that the data point regarding the number of unsheltered adults (10.01%) and sheltered adults (10.40%) who reported experiencing domestic violence is calculated based on those who responded to the PIT survey question about domestic violence. Chair Maricela Rios-Faust suggested asking all survey participants, regardless of gender, if they are experiencing domestic violence. Chair Maricela Rios-Faust suggested that it would be beneficial to understand the reasons behind an individual's reluctance to share whether they were experiencing domestic violence. Chair Maricela Rios-Faust suggested asking individuals if they have experienced domestic violence while being homeless.
- Wendy Seiden shared about previous experience when working with women who
 experienced domestic violence on the riverbed. Wendy Seiden shared several examples
 of why an individual may not disclose if they are experiencing domestic violence. Wendy
 Seiden suggested the PIT Count should be longer than ten days, to get a more accurate
 count of people experiencing homelessness.
- Mark Lee inquired if the PIT survey asked about human trafficking in addition to domestic violence.
- CoC Program Notice of Funding Opportunity (NOFO) Feedback Sarah Jones, CoC Manager; Felicia Boehringer, CoC Administrator; and Jasmin Miranda, CoC Staff Specialist, Office of Care Coordination

Sarah Jones, Felicia Boehringer and Jasmin Miranda presented on the upcoming Fiscal Year (FY) 2024 CoC Program NOFO. The CoC Program NOFO competition, administered by the Department of Housing and Urban Development (HUD) on an annual basis, invites CoCs nationwide to compete for funding. The process starts with CoC registration, followed by the review of Grant Inventory Worksheets (GIW) and the release of the CoC Program NOFO. In Orange County, the Office of Care Coordination serves as the Collaborative Applicant and manages the local competition process. The Consolidated Application, submitted to HUD, includes the final Project Priority Listing and the CoC Application with narrative and data-related responses. Key entities involved in the process include the County of Orange as the Collaborative Applicant, Orange

County United Way 2-1-1 Orange County as the HMIS Lead, CoC NOFO Ad Hoc, and CoC Board. These entities develop NOFO policies, review and evaluate project applications, and approve final Project Priority Listings.

The Orange County CoC currently holds \$3,297,106 in Domestic Violence (DV) Bonus funding for various projects including Joint Transitional Housing/Permanent Housing Rapid Rehousing (Joint TH/PH-RRH), Rapid Rehousing (RRH), and Coordinated Entry System Supportive Services Only (SSO) projects. The increased funding for FY 2023 is attributed to the rise in Fair Market Rent (FMR). During the CoC Program NOFO process, CoCs can renew existing projects, apply for new projects, and reallocate resources to better serve people experiencing homelessness. The Office of Care Coordination, as the Collaborative Applicant for the Orange County CoC, releases an application for CoC Renewal Projects and Request for Proposals (RFP) for CoC Bonus, DV Bonus, and Reallocation Projects. DV Bonus eligible projects serve survivors of domestic violence, dating violence, sexual assault, or stalking who qualify as homeless. Prior to releasing the DV Bonus RFP, the CoC NOFO ad hoc sets recommendations of priorities to the CoC Board. In FY 2023, the CoC NOFO ad hoc recommended the priority of soliciting new RRH and Joint TH/PH-RRH projects.

Committee Discussion:

- Wendy Seiden sought clarification on how new projects and renewal projects are funded.
- Chair Maricela Rios-Faust provided a thorough explanation of the allocation process and bonus funding. Chair Maricela Rios-Faust inquired if it would be possible for the DV Bonus to be used for Permanent Supportive Housing (PSH).
- Mark Lee expressed support for the Joint TH/PH-RRH project type. Mark Lee inquired about the existence of a baseline standard for each program. Mark Lee inquired if there is a possibility to prioritize PSH for DV Bonus funding.
- Brateil Aghasi stated that Joint TH/PH-RRH projects need up to 24 months to fully execute.
 Brateil Aghasi shared that the City of Santa Ana has allocated 15 units for set aside vouchers specifically for survivors of domestic violence.

Public Comment:

- Sara Behmerwohld highlighted that over the past two years, the CoC Program NOFO elevated individualized support for the DV Bonus funding recipients. Sara Behmerwohld stated that the current Orange County CoC renewal project scoring criteria is not in alignment with HUD's individualized approach for an individual experiencing domestic violence.
- **4. CoC Updates** Sarah Jones, CoC Manager, Office of Care Coordination

Sarah Jones presented the following CoC updates:

FY 2024 CoC Program NOFO - The upcoming FY 2024 CoC Program NOFO is anticipated to be released by the U.S Department of Housing and Urban Development (HUD) in early Summer 2024. On June 11, 2024, the Office of Care Coordination, as the Collaborative Applicant for the Orange County CoC, released the FY 2024 Agency Administrative Review for CoC Funded Agencies in preparation for the FY 2024 CoC Program NOFO competition. visit FY 22024 Program To the CoC NOFO webpage, please visit https://ceo.ocgov.com/fy2024cocnofo

- Youth Homelessness Demonstration Program (YHDP) NOFO On June 6, 2024, HUD announced the release of the YHDP NOFO, making approximately \$72 million available nationally to support selected communities in preventing and ending youth homelessness. The Office of Care Coordination aims to strengthen the YHDP Round 7 funding application for the Orange County CoC by capturing progress made towards youth engagement in decision making and working closely with local partners. The YHDP application must be submitted by August 29, 2024.
- 2024 VAWA and Survivor Housing Community Conversations HUD is hosting a series of
 community conversations focused on successfully implementing the Violence Against
 Women Act (VAWA) and survivor centered housing at the system, project, and human
 levels. Each conversation will feature a diverse panel of system leaders, project staff, and
 people with lived experiences from both the homelessness response and victim services
