FY2024 CoC Program NOFO Overview

CoC Program NOFO

- The CoC Program NOFO Competition is facilitated by HUD and occurs annually, inviting CoCs from across the nation to apply for competitive funding.
- Each Fiscal Year (FY) Competition process begins with Registration of the CoC by the CoC Collaborative Applicant, followed by the review of the CoC's Grant Inventory Worksheets (GIW) and the release of the CoC Program NOFO.
- The Office of Care Coordination, as the Collaborative Applicant for the Orange County CoC, facilitates the local competition process and completes the Consolidated Application that is submitted to HUD, consisting of:
 - ❖ Final Project Priority Listing with the ranking and tiering of new and renewal projects
 - ❖ CoC Application, which includes responses to multiple narrative and data-related questions
- **Lead entities involved:**
 - ❖ County of Orange – Collaborative Applicant to coordinate and complete Consolidated Application
 - ❖ CoC NOFO Ad Hoc (NOFO Ad Hoc) – Develop NOFO policies and processes, including Scoring and Rating criteria, review and evaluate the CoC Renewal Project Applications
 - ❖ CoC Board – Review and approve CoC NOFO policies and processes, including Scoring and Rating criteria and Ranking and Tiering policy; approve final Project Priority Listing, as recommended by the NOFO Ad Hoc

FY2024 CoC Program NOFO Overview

FY 2024 and FY 2025 CoC Program NOFO Competition

NOFO Release

- HUD released the FY 2024 and FY 2025 CoC NOFO Competition (FY24/25 NOFO) on Wednesday, July 31, 2024.
- **For the first time, HUD is issuing a 2-year CoC Program NOFO** as authorized by the consolidated Appropriations Act, 2024.

Funding Available Nationwide:

- CoC Program – \$3,524,000,000
- Domestic Violence (DV) Bonus – \$52,000,000
- Youth Homelessness Demonstration Program (YHDP) – \$188,000,000
- A portion of funds will be available for CoC Renewal Projects and CoC Bonus Projects.

Funding Available to the Orange County CoC:

- Estimated Annual Renewal Demand (ARD) – \$32,801,133
- CoC Bonus – \$3,936,136
- DV Bonus – \$3,623,391
- CoC Planning – \$1,500,000

CoC Bonus and Reallocation Funding

CoC Bonus Funding Overview

- CoC Bonus Funding Available to the Orange County CoC: **\$3,936,136**
- Eligible CoC Bonus and/or Reallocation project types:
 - ❖ Permanent Housing – Rapid Rehousing (RRH) projects
 - ❖ Permanent Housing – Permanent Supportive Housing (PSH) projects
- The RFP will be utilized to identify new projects and/or expansion projects for the CoC Bonus available through the FY2024 CoC Program NOFO funding and any additional reallocation funds that become available.
- All proposed services must be new, and proposed project funding cannot replace other existing funding sources.

CoC Bonus and Reallocation Funding

Reallocation Funding Overview

- Current reallocation funding available: **\$242,702** in funding to solicit new **PSH** project proposals that serve **Older Adults** (ages 62 and older).
- The CoC Board accepted voluntary reallocation of funding from Anaheim Supportive Housing's Tyrol Plaza Senior Apartments project for Older Adults in Anaheim, part of Orange County's North Service Planning Area.
 - ❖ 12 units/households are only receiving supportive services under the CoC grant funding, as rental assistance is provided through an Anaheim Supportive Housing voucher.
 - ❖ Two (2) units/households are receiving both rental assistance and supportive services through the CoC grant.
- Proposals for the reallocation funding should seek to propose a new or expansion project that includes a tenant-based, scattered-site model allowing for current program participants housed in the Anaheim project to be served as well as new program participants regionally throughout Orange County.
- Note: Additional reallocation may be available as the evaluation of renewal projects is still underway

CoC Bonus and Reallocation Funding

CoC Bonus and Reallocation Funding: Eligible Populations to be Served

- Eligible households to be served with CoC Bonus and/or Reallocation funding:
 - ❖ CoC Bonus: Persons who qualify as homeless under paragraphs (1), (2), or (4) of 24 CFR 578.3 or Section 103(b) of the McKinney-Vento Homeless Assistance Act coming directly from the streets or emergency shelters and include persons fleeing domestic violence situations and other people meeting the criteria of paragraph (4) of the HUD definition of homeless.
 - ❖ Reallocation Funding: Older Adults (ages 62 and older) experiencing homelessness, either sheltered or unsheltered per the HUD definition of homeless.

CoC Bonus and Reallocation Funding

Focusing on Severe Service Needs

- CoC Bonus and Reallocation projects will prioritize serving households with severe service needs and undeserved communities. Severe service needs means any combination of the following factors:
 - ❖ Facing significant challenges or functional impairments, including any physical, mental, developmental or behavioral health disabilities regardless of the type of disability, which require a significant level of support in order to maintain permanent housing (this factor focuses on the level of support needed and is not based on disability type);
 - ❖ High utilization of crisis or emergency services to meet basic needs, including but not limited to emergency rooms, jails, and psychiatric facilities; currently living in an unsheltered situation or having a history of living in an unsheltered situation; experiencing a vulnerability to illness or death;
 - ❖ Having a risk of continued or repeated homelessness; and
 - ❖ Having a vulnerability to victimization, including physical assault, trafficking, or sex work.
- Should primarily serve (75 percent or more) households with severe service needs or include designated units to serve any of the following populations, including families (households with at least one minor child and one adult), Transitional Age Youth (TAY) (ages 18 – 24), individuals (adult only households) experiencing chronic homelessness and older adults (ages 62 and older).

DV Bonus Funding

Domestic Violence (DV) Bonus Funding Overview

- DV Bonus Funding Available to the Orange County CoC: **\$3,623,391**
- Eligible DV Bonus project types:
 - ❖ Permanent Housing – Rapid Rehousing (RRH) projects
 - ❖ Joint Transitional Housing and Permanent Housing – Rapid Rehousing (Joint TH/ PH-RRH) Projects
- Eligible households to be served with DV Bonus funding:
 - ❖ Survivors of domestic violence, dating violence, sexual assault, or stalking that are defined as homeless (24 CFR 578.3).
 - ❖ Per the FY2024 and FY2025 CoC Program NOFO, new projects and expansion projects proposed and funded through the DV Bonus cannot exclusively serve people fleeing or attempting to flee human trafficking but may serve this segment of the population as part of the total population to be served.

Domestic Violence (DV) Bonus Funding Overview and Priorities

- Eligible households to be served with DV Bonus funding (cont.):
 - ❖ For purposes of the CoC Program and other HUD programs authorized by the McKinney-Vento Homeless Assistance Act, section 605 of Violence Against Women Act (VAWA) 2022 amended section 103(b) of the McKinney-Vento Homeless Assistance Act to require HUD to consider as homeless: any individual or family who—
 - is experiencing trauma or a lack of safety related to, or fleeing or attempting to flee, domestic violence, dating violence, sexual assault, stalking, or other dangerous, traumatic, or life-threatening conditions related to the violence against the individual or a family member in the individual's or family's current housing situation, including where the health and safety of children are jeopardized;
 - has no other safe residence; and
 - lacks the resources to obtain other safe permanent housing.

Scoring and Rating Criteria

FY2024 CoC Bonus, DV Bonus and Reallocation Scoring and Rating Criteria

- The FY2024 CoC Bonus, DV Bonus and Reallocation Scoring and Rating Criteria is to be utilized to determine the Tiering and Project Priority Listing for CoC Bonus, DV Bonus and/or Reallocation projects as part of the annual CoC Program grant application.
- All projects, except Joint TH/PH-RRH projects, will be scored on a 150-point scale.
 - ❖ Any Joint TH/PH-RRH project proposals will be evaluated on a 130-point scale, as Joint TH/PH-RRH project types will not be scored on the Leveraging of Resources

5	Proposed Project Service Plan and Supportive Services	Up to 30 points	<ul style="list-style-type: none"> Proposed project, including service plan and supportive services, is appropriate for the household type and/or subpopulation. Proposed project includes strategies to assist participants to obtain and remain in permanent housing, increase their employment and/or income and maximum their ability to live independently. Proposed project will implement a Housing first, client-centered approach; plan to address the housing and safety needs of survivors of domestic violence, sexual assault and stalking² by adopting victim-centered practices ; and other evidence-based practices in program operations. To receive full points, applicants must clearly describe the evidence-informed practices that the project will use in policies, procedures, and operations. Proposed project will have tailored approach to serve people with severe service needs and communities who are substantially overrepresented in the homeless population. Proposed project will address and eliminate barriers experienced by people disproportionately impacted by homelessness, including individuals and families who are within the Black or African American; American Indian, Alaska Native, or Indigenous; Latina/e/o; and Lesbian, Gay, Bisexual, Transgender, Queer or Questioning, Intersex, Asexual, and Other Gender or Sexual Identities (LGBTQIA+) communities.

Proposed performance outcomes should focus on participants housing placement and permanent housing retention, as well as improved quality of life, rather than measuring the amount or types of services provided (not outputs).

(iii) Provide formal written agreements that include the value of the commitment and dates the healthcare resources will be provided.
