

COMPARISON OF 2019, 2022 & 2024 VETERAN POINT IN TIME COUNT


TOTAL COMPARISON OF 2019, 2022 & 2024 POINT IN TIME COUNT



Homeless Veterans on Veteran Registry



Currently, there are 261 veterans experiencing homelessness on the Veteran Registry. In the previous 12 months, 156 veterans have been housed in permanent, stable housing. Over 30 agencies, including the VA Community Resource and Referral Center, outreach providers, and shelter providers, continue to meet weekly to coordinate housing and services for veterans experiencing homelessness in Orange County. In the past 12 months, there has been a 4% decrease in the number of veterans experiencing homelessness in Orange County.

Inflow vs. Outflow by Month



What is One Team?

- A One Team approach refers to coordinated, united actions and interconnection between programs as they work toward the joint mission to end Veteran homelessness.
- It means we are all working as one system versus multiple programs and organizations.

Leadership Matters

- 2024 VA Homeless Programs National Conference
 - Identified specific community goals
 - Building a Leadership Team was a #1 priority

VA Long Beach One Team

- A group of Veteran system leaders & decision-makers focused on advancing the goals of the system
- Actively problem-solve/barrier bust issues based on feedback from the Veteran homelessness system.
 - Make decisions in real-time and not over a series of months
- Identify areas of opportunity to improve the system for Veterans to have a seamless service experience anywhere in the VA's catchment area.
- Share lessons-learned with each other to strengthen our processes and systems

One Team Vision, Values and Goals

Values

- Veteran Centered- Recognizing their experiences, needs and desires.
- Housing focused- Housing ends homelessness
- Ease of use- processes should be easy to navigate for Veterans and staff.
- Rapid delivery of services- Minimal barriers, few delays to housing.

Principles to Lead Our Work

- Create a high functioning Veteran homelessness crisis response system.
- Increase utilization of HUD-VASH and maximize all Veteran housing resources, including the array of SSVF options.

WHAT IS THE HUD-VASH PROGRAM?

- It is a national program that partners Veterans Affairs Supported Housing (VASH) with the Department of Housing and Urban Development (HUD).
- It provides clinical case management support services that connects Veterans to both community and VA resources.
- It is designed to remove financial and other barriers for Veterans with low income to secure subsidized permanent housing.
- It is supported by Long Beach and Orange County Housing Authorities which provide Housing Choice Vouchers.



HOUSING CHOICE VOUCHERS


- Veterans pay 30%-40% of their adjust gross income towards rent and HUD pays the rest.
 - Ex. Veteran pays \$200.00 + HUD pays \$2,000.00 = Landlord receives \$2,200.00
- Veterans can choose the type of unit they want to rent; apartments, studios, mobile homes, condo, shared housing, or a house.

Types of HUD-VASH Vouchers

- There are 2 types of HUD-VASH vouchers
 - Tenant Based Vouchers
 - Project Based Vouchers
- Tenant-Based vouchers (TBV) are tied to the Veteran. The Veteran receives the voucher and searches for housing in the community.
- Project-Based (PBV) vouchers are tied to specific properties. When the Veteran applies for a PBV they are applying for the voucher and the building at the same time.

 - Placentia Veterans Village (49)- Placentia
 - Salida Del Sol (10)- San Juan Capistrano (Opening late 2024/early 2025)

Housing Veterans: Lessons Learned

PBVs Lessons Learned

- Veterans tend to prefer 1 bedrooms to studios apartment. Studios are often declined.
- Income caps on PBV buildings can limit eligibility for higher income Veterans.
- Location of PBV buildings can impact ability to fill these units.

TBVs Lessons Learned

- Finding a unit can be a lengthy process due to limited housing inventory and Veteran preference.
- Shared Housing is an alternative option for Veterans, but many Veterans want to live alone.
- Assisted Living Facilities are a new options but presents challenges due to cost.

CoCBuilds NOFO

- The U.S. Department of Housing and Urban Development (HUD) is making approximately \$175 million in funding available through the CoCBuilds NOFO a first-of-its-kind funding for new construction, acquisition, or rehabilitation of permanent supportive housing (PSH).
- The Orange County CoC is eligible to apply for a maximum of \$7,500,000.
- Through one-time awards under the CoC program, the CoCBuilds NOFO will enable communities to develop new units of rental housing with supportive services for people experiencing homelessness.
- CoCBuilds grant terms may be two, three, four, or five years. Projects selected for conditional award must be able to:
 - a. provide proof of site control (24 CFR 578.25) prior to execution of the grant agreement; and
 - b. execute the grant agreement with HUD no later than September 1, 2025

- The submission deadline for the CoCBuilds NOFO is November 21, 2024, at 9:00 p.m. PDT.

CoCBuilds NOFO RFP
