Recommended Actions:

Approve Jamboree Housing Corporation's permanent supportive housing project proposal called Costa Mesa Senior submitted in response to the CoCBuilds Projects Request for Proposals (RFP), for inclusion in the Orange County CoC CoCBuilds NOFO Application to the U.S Department of Housing and Urban Development (HUD), as recommended by the CoCBuilds NOFO ad hoc.
- b. Approve CoC Board Chair and Officers' letter of support for application submission of the CoCBuilds NOFO.

Background and Analysis

Selection of Proposals in Response to the CoCBuilds Projects RFP

HUD is making approximately \$175 million in funding available through the CoCBuilds NOFO – a first-of-its-kind funding for new construction, acquisition, or rehabilitation of permanent supportive housing (PSH). Through one-time awards under the CoC program, the CoCBuilds NOFO will enable communities to develop new units of rental housing with supportive services for people experiencing homelessness. The submission deadline for the CoCBuilds NOFO is November 21, 2024, at 9:00 p.m. PDT. The Orange County CoC is eligible to apply for \$7,500,000 during the CoCBuilds NOFO.

During the August 28, 2024, meeting of the CoC Board, the Orange County CoC Board approved the recommendation to establish a non-conflicted ad hoc to evaluate proposals submitted in response to the RFP for the CoCBuilds NOFO. In partnership with the Office of Care Coordination as the Collaborative Applicant, the CoC Board Officers appointed the ad hoc membership, that is comprised of Zac Henson, Orange County Public Works; Marisol Johnson, Dayle McIntosh Center; Starteasha Johnson, Orange County Housing and Community Development and Maricela Rios-Faust, Human Options. Prior to the evaluation of proposals, it was identified that Starteasha Johnson held a conflict of interest and stepped down from the ad hoc. It was determined that the remaining three ad hoc members would continue with the RFP evaluation as planned.

On September 12, 2024, the Collaborative Applicant for the Orange County CoC released the local RFP to solicit proposals from qualified organizations for a PSH project to be potentially funded by the funding available through the CoCBuilds NOFO. The submission deadline was Friday, October 4, 2024, at 5:00 p.m. and a total of three project proposals were submitted. The members of the CoCBuilds NOFO ad hoc independently reviewed the three proposals and scored each application based on the scoring criteria as outlined in the RPF. The CoCBuilds NOFO ad hoc participated in a meeting on October 29, 2024, to review all project proposal evaluation scores collectively, discuss the proposals at length, provide feedback on areas for improvement and highlight the unique strengths of each proposal. Utilizing an overall average

score for each proposal and the discussion during the meeting, the CoCBuilds NOFO ad hoc recommended the proposal with the highest score to be recommended to the CoC Board for approval. Jamboree Housing Corporation (Jamboree)'s PSH project proposal called Costa Mesa Senior in the amount of \$7,500,000 is being recommended for inclusion in the Orange County CoC CoCBuilds NOFO Application submitted to HUD. The Costa Mesa Senior project is proposing to serve Older Adults through 69 total affordable units, inclusive of 34 one-bedroom units for households experiencing homelessness with a disability at or below 30% of the Area Median Income (AMI), 34 one-bedroom units for households at or below 60% of the AMI. Half of the proposed units (34) will be PSH units that serve older adults with a mental health diagnosis using a leveraged commitment of Mental Health Services Act (MHSA) funding through the Orange County Housing Finance Trust and Orange County Housing and Community Development. All PSH units funded with CoCBuilds funding will be matched through the Coordinated Entry System (CES). The CoCBuilds funding would provide gap funding to the Costa Mesa Senior project to ensure successful execution and implementation The Collaborative Applicant will work with Jamboree to update their proposal accordingly to ensure the most competitive project application is submitted to HUD, if approved by the CoC Board.

Approval of Jamboree's PSH project proposal will allow the Orange County CoC to apply for the CoCBuilds NOFO to support the ongoing efforts to continue developing housing opportunities and address and reduce the number of people experiencing homelessness.

CoC Support Letter

As described in Section III.D.2. of the CoCBuilds NOFO, CoCs are required to include a letter signed by the CoC Board President stating the CoC supports the submission of the selected application. HUD also released the "CoCBuilds NOFO Application Responsibilities Project Applicant vs Collaborative Applicant" document that clarifies that the letter can be signed by the CoC Board President or Committee, which is known as the CoC Board Chair or a CoC Committee in the Orange County CoC. Because of this, the Collaborative Applicant is also seeking support from the Orange County CoC Board membership to approve the CoC Board Chair and Officers to sign a letter of support for the CoCBuilds NOFO application submission.

The drafted letter of support, inclusive of the CoC number and name, name of the applicant organization, name of the project, and amount of funds being requested, can be referenced in **Attachment A**.

To Whom It May Concern:

This letter is to express strong support for the application that the Orange County Continuum of Care (CoC) CA-602 is submitting to the U.S. Department of Housing and Urban Development (HUD) under the CoCBuilds Notice of Funding Opportunity (NOFO).
