During the FY2024 CoC Program NOFO competition, Anaheim Supportive Housing, Inc. notified the Collaborative Applicant about the intent to voluntarily reallocate the full renewal funding amount of \$242,702 for the Tyrol Plaza Senior Apartments project. On July 25, 2024, the project applicant was notified that at the July 24, 2024, meeting of the CoC Board, the recommendation to accept the voluntary reallocation of \$242,702 in funding from Anaheim Supportive Housing, Inc.'s Tyrol Plaza Senior Apartments project was approved. The project applicant was then notified on October 10, 2024, that the Tyrol Plaza Senior Apartments project was excluded from the FY2024 CoC Program NOFO Priority Listing, as approved by the CoC Board on October 9, 2024.






