Two of the CoC's goals resonate with me because they are intertwined: ensuring an efficient and dignified system and promoting an equitable and just system. I plan to contribute to these goals by actively participating in the various roles and processes of the CoC, such as contributing to committees, advocating for clients and services, challenging inequities, identifying strategies for improvement, recognizing my sphere of influence and championing partners into this space, collaborating, supporting best practices and bright spots, and taking a system's level view to make the greatest impact.

Please discuss one (1) significant challenge to addressing homelessness in Orange County. If you could wave a magic wand to address this challenge, what would your solution be?

One significant challenge to addressing homelessness in Orange County is timely access to shelter and housing opportunities. If I had a magic wand to address this challenge, the system would 1. have daily access to a variety of shelter options that were varied to meet the diverse needs of the unhoused community (i.e. specialized populations, culturally competent, local to their city of residence, inclusive of pets, families, and couples, non-congregate options, and accepting of sex offender status), and 2. move chronically and newly homeless and vulnerable populations into a permanent housing option quickly (including the process of housing application, navigation, and move in). These are lofty goals that require complex and multi-sector collaboration, resources, and political will. Although I do not have the solution, I am hopeful we will solve homelessness in Orange County by working together to generate innovative and creative solutions that encompass dignity, compassion, and equity.
