In addition to the facilitation and regional collaboration of housing opportunities in Orange County, the Housing Opportunities Committee will align its efforts with the Orange County CoC Board Vision.

## **MINUTES**

Welcome and Call to Order - Judson Brown, Chair and January Johnson, Vice Chair

Chair Judson Brown called the meeting to order at 10:05 a.m.

**Public Comments** – Members of the public may address the Housing Opportunities Committee on items listed within this agenda or matters not appearing on the agenda so long as the subject matter is within the jurisdiction of the Housing Opportunities Committee. Comments will be limited to three minutes. If there are more than five public speakers, this time will be reduced to two minutes.

- **1. Orange County 2024 Point In Time Count** Sarah Jones, Office of Care Coordination; Chair Judson Brown and Vice Chair January Johnson

Sarah Jones provided a brief overview of the 2024 Point In Time Count results.

#### Committee Discussion:

- Adam Eliason inquired as to why there was a large discrepancy in veterans who are unsheltered
  and sheltered veterans. Adam Eliason asked if there are any efforts being done by non-profits or
  other agencies in regard to transitioning individuals from permanent supportive housing (PSH) to
  a graduated market rate type of housing.
- Curtis Gibbs shared that CalOptima Health is tracking their own data regarding people who are experiencing homelessness and noted the number of housing navigator organizations that are contracted with CalOptima Health.
- Elizabeth Hansburg asked for clarification on the role of the BellWell campuses being shown as
  prevention services. Elizabeth Hansburg asked if there was data on the numbers of families
  experiencing homelessness for the first time. Elizabeth Hansburg advocated for the need of a
  housing bond.
- Chair Judson Brown inquired if the "1,533 traditional Housing Choice vouchers issued" metric included Emergency Housing Vouchers (EHVs) and asked if there was a breakdown of supportive units for the "1,364 affordable and supportive housing units" metric. Chair Judson Brown shared information related to City of Santa Ana and the Point In Time Count results.
- Cesar Covarrubias stated that the current housing market is a different situation and advocated for a need of preventing homelessness today. Cesar Covarrubias shared that common stories being shared are regarding family housing instability, sharing apartments, renting out garages, and noted that many are one situation away from being on the streets.
- Vice Chair January Johnson explained that individuals can graduate from PSH to another type of vouchers which ultimately fees up a PSH unit. Vice Chair January Johnson shared that there needs to be different approaches depending on the populations. Vice Chair January Johnson noted Santa

Ana's Family Self-Sufficiency (FSS) programs and the intent of wanting to see families succeed and move on.

Michelle Zdeba shared previous experience of service providers emphasizing on having people
graduate from the program but noted that there is limited funding and a lack of resources for all
parts. Michelle Zdeba posed a question for the group and asked how resources can be used to
address issues on the back end and address homelessness on the front end.

#### 2. Community Needs Assessment – Curtis Gibbs, Community Action Partnership of Orange County

Every two years, Community Action Partnership of Orange County (CAP OC) conducts a Community Needs Assessment (CNA), which aims to understand the emerging and ongoing needs. This helps to guide CAP OC's efforts and strategies for the upcoming years and create actionable plans to support individuals and families affected by poverty. #### 3. Project-Based Housing Updates

- a. OC Housing Finance Trust (OCHFT) Update Adam Eliason, OCHFT
- Adam Eliason announced that there have been development grand openings in Santa Ana, California. Regarding OCHFT funded projects, OCHFT has funded 27 projects since its formation, including 13 projects in pre-development, 7 projects under construction, and 7 projects completed. OCHFT is expecting to release a Notice of Funding Opportunity (NOFO) for capital funding as OCHFT is expecting an allocation of funding next year.

a. Special Purpose Voucher Updates – PHA Representatives

#### 5. Federal and State Legislation Updates – Cesar Covarrubias, The Kennedy Commission

#### Committee Discussion:

- Adam Eliason shared that San Gabriel Valley Trust has some developments that utilized a pallet model
- Nishtha Mohendra provided the example of one of American Family Housing's project that used
  pallets and shipping containers and shared some of the learning such as the cost intensiveness,
  the permitting process, and the cost of air conditioning the units.
- Regarding Senate Bill 1211, Elizabeth Hansburg inquired if there was concern about garages turning into housing and the possibility of people losing access to their garage, especially in areas that are heavily parking impacted.
- Marisol Johnson shared that there is a lack of public transportation is some areas and developments.
- Regarding Assembly Bill 1788, Rebecca Kovacs-Stein shared their view of what the bill is addressing.
