Please discuss one (1) significant challenge to addressing homelessness in Orange County. If you could wave a magic wand to address this challenge, what would your solution be?

In my experience, one of the most significant challenges in addressing homelessness in Orange County is the shortage of housing vouchers and the scarcity of affordable housing units, particularly those that will accept vouchers. This combination creates a bottleneck where individuals and families, even those who qualify for assistance, struggle to secure stable housing.

The challenge is twofold: first, the high cost of housing in Orange County leaves many voucher recipients unable to find suitable units within the allotted budget, and second, there is often reluctance among landlords to rent to individuals who are experiencing or have experienced homelessness. This reluctance may stem from misconceptions, fears of potential property damage, or concerns about financial reliability, despite the guarantees that vouchers can offer.

If I could wave a magic wand, my solution would start with increasing outreach and education efforts targeted toward landlords and property owners. Educating them on the benefits of voucher programs, such as reliable rent payments backed by government funds, tenant support services, and the overall social impact of helping individuals transition out of homelessness, could help mitigate their hesitations. Partnering with local housing authorities and community organizations to create incentives for landlords—such as tax breaks, repair funds, or other financial incentives—could further encourage more property owners to participate in these programs. By addressing both the supply of vouchers and the availability of affordable, accessible housing, we can help remove barriers that prevent many individuals and families from securing a stable home and move closer to ending the cycle of homelessness.
