What qualities, skills, and experience do you bring that would help the CoC Board to further its work in ending homelessness and furthering equity and inclusion?

I have served as a member of the Continuum of Care Governing Board, for the past 6 years. During this time I have leveraged my experience in the domestic violence field as well as my experience offering housing options for those fleeing abuse to explore opportunities to strengthen the continuum of care for homeless individuals and families. I served as the Vice Chair in 2021, in that capacity I chaired the Policies Procedures and Standards Committee, served as the Chair of the Board (2022), and most recently served as the chair of the DV Committee.

Additionally, while a member of the Governing Board I have participated on RFP review panels. This has deepened my understanding of how the Continuum of Care can continue to maximize resources and strategically move in the direction of ending homelessness.

I have been a part of Orange County's Continuum of Care for over 16 years. During this time I have have been involved in various high level strategic discussions on the Coordinated Entry System and Homeless Management Information System. I believe that effectively integrating data from the HMIS system and a comparable database can play a key role in understanding the complex housing needs of homeless individuals and families. These combined data points can then inform strategies, coordinate resources and identify needed support to vulnerable individuals and families experiencing homelessness.

As a current board member I have a greater understanding of how the CES and HMIS system operate in OC and various counties through out CA. This last year my team began work to identify ways in which we can improve access to data regarding individuals with our system

As a DV service provider we collect, maintain and track participant data in a comparable data base to HMIS. This data can be made available in aggregate form to the CoC.

What qualities or characteristics do you bring to a collaborative environment?

I have extensive experience working in collaborative environment to drive toward shared goals. I do this through open communication and prioritize goals that align with the community's needs. I take the time to understand others' viewpoints and approach the collaborative process with a positive mindset. I value the perspective of individuals from diverse backgrounds and believe that individuals with lived experience have valuable expertise to inform our collective work together.

As a member of the CoC Board I engage in systems level dialogue around opportunities for leveraging funding, improving outcomes and improving the systems of care. Additionally, I participate on a statewide cohort focused on improving housing options and outcomes.

Without targeted services, they face greater risks of exploitation, trauma, and chronic homelessness. Housing instability impacts children's education, social development, and mental health, creating long-term consequences for both children and parents.

If I had a magic wand, I would support a multi-faceted approach that includes expanding affordable housing, improving access to mental health, fostering community acceptance, and creating economic opportunities. With coordinated efforts across public, private, and nonprofit sectors, OC can create more sustainable, comprehensive solutions that address both immediate needs and long-term housing stability.
