Our Services

Peer Crisis Counseling & Peer Navigation

Free non-clinical counseling for all ages; assistance in applying for CalFresh, Medi-Cal, SSI and other government benefits; substance use and rehabilitation resources; housing resources and referrals; family support services: resume and job search assistance; and comprehensive resource referrals.

Justice-Involved Navigation Services

Courtroom supportive services; CARE Court; training and education; job placement; re-entry navigation and Peer support; comprehensive resources; and Homeless Outreach Court.

Peer-to-Peer and Community Health Worker Support

Free support group facilitator training; personal development ahead of certification exams; job placement; a Volunteer Development Program with internship opportunities; and supportive services.

Homeless & Hoarding Support Services

Support for vulnerable populations including those without housing; one-on-one help; direct housing referrals; and educational/supportive services.








FIGURE 6: OPIOID-RELATED OVERDOSE DEATHS AMONG YOUTH AND YOUNG ADULTS (2017-2021)





Through providing resources, mentorship and education to youth, Peer Voices and our Partners help support Early Intervention and Outpatient Services in the Continuum of Care Model

by Level of Care, California, 2019









Youth Homelessness Demonstration Program (YHDP) Funding

- On October 30, 2024, the U.S Department of Housing and Urban Development (HUD) announced the award of \$72 million to 14 communities under the Youth Homelessness Demonstration Program (YHDP).
- This funding will help the awarded communities create opportunities that are specialized to support
 youth experiencing homelessness, including rental assistance for affordable housing units and wraparound services to improve overall health and wellness in an effort to obtain and maintain stable
 housing.
- Though the Orange County CoC was not awarded YHDP funding, the CoC plans to continue applying for future opportunities to serve more youth experiencing homelessness.

AmeriCorps California Opportunity Corps Pilot Funding Opportunity

- California Volunteers, Office of the Governor is the State Service Commission for California and is now
 accepting applications for a two-year pilot program to support the unhoused community through
 national service. The funding opportunity includes a planning grant and two years of implementation
 funding, including federal funds, state funds, and an allotment of full-time or part-time AmeriCorps
 member positions.
