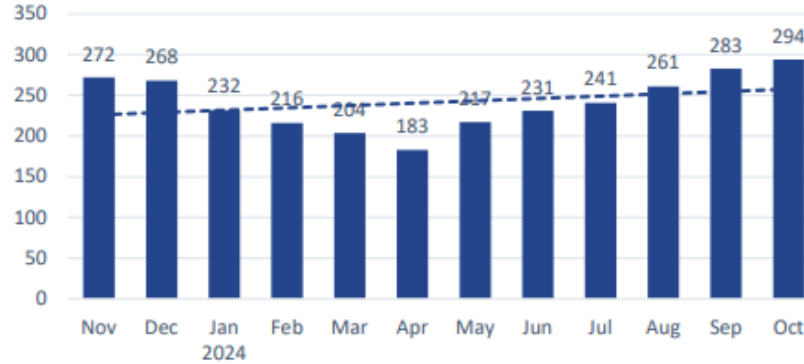

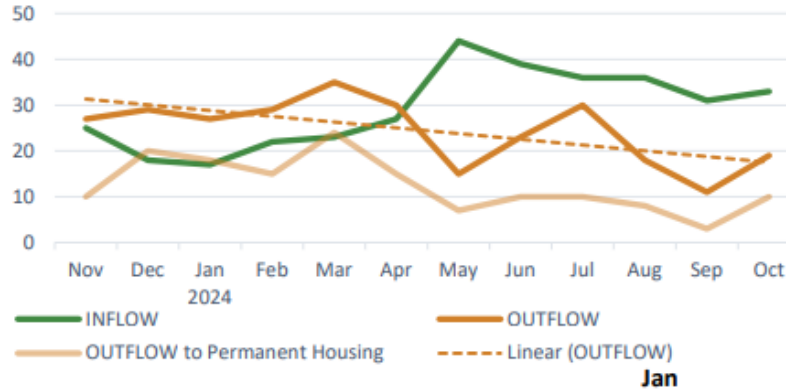
## Veteran Registry Dashboard

### Homeless Veterans on Veteran Registry



Currently, there are 294 veterans experiencing homelessness on the Veteran Registry. In the previous 12 months, 150 veterans have been housed in permanent, stable housing. Over 30 agencies, including the VA Community Resource and Referral Center, outreach providers, and shelter providers, continue to meet weekly to coordinate housing and services for veterans experiencing homelessness in Orange County. In the past 12 months, there has been an 8% increase in the number of veterans experiencing homelessness in Orange County.

### Inflow vs. Outflow by Month

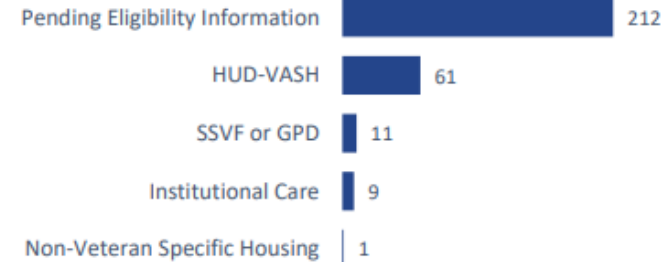
