#### **❖ INTRODUCTION**

As California's third largest county and the sixth largest in the nation, Orange County is a diverse and productive municipality dedicated to maximizing resources and improving the quality of life for its 3 million residents. To meet this goal, the Orange County Board of Supervisors, in consultation with its departments and agencies, is pleased to present the 2017-18 Legislative Platform.

From afar, Orange County is most known for its glitzy tourist attractions, world-class beaches and parks, cutting-edge tech industries and its entrepreneurial spirit. Yet the sidewalk view is far different for many here, leading to challenges as unique to Orange County as its opportunities. Despite a dynamic population experiencing the same urgent needs as other urban counties, Orange County remains dead last in the return of local property tax dollars desperately needed to fund essential services and programs.

Many Orange County residents count on the support they receive from County government, whose dollars already are stretched thin by multiple demands: One of every three residents receives some form of social-service assistance. One in five residents live in poverty. One of every six residents uses the services provided through the County's indigent medical system, CalOptima. Orange County's cost of living is 85% higher than the national average. Two-thirds of local jobs pay less than the minimum needed to rent a one-bedroom apartment.

The State and Federal governments have partnered with Orange County to fund a myriad of essential programs. Local dollars are leveraged where possible to increase funding and to supplement where no funding exists. The County needs more tools to pool resources and maximize funding, including allowing tax dollars generated locally to be put to work locally instead of exported elsewhere. The County needs flexibility to use all funds available in creative and productive ways, and to seek partnerships with the State and Federal governments, cities and the private sector to find more ways to say yes to innovative programs targeting those in need.


The Board works closely with its legislative and congressional delegations to achieve these goals. The Legislative Platform establishes priorities and policy statements to alert our legislative partners of the greatest needs of our residents and where we need additional help. It also provides general direction to County departments, legislative advocates, delegation members and the public on our positions of support or opposition to key policy initiatives that would impact the way the County does business. Finally, it also includes new bill requests for which legislators are sought to carry proposed legislation on the County's behalf.

Because the Legislative Platform is approved prior to the beginning of each two-year State and Federal legislative session, it is not always possible to anticipate additional legislative, regulatory and/or budgetary issues that may arise at a later date. Thus, the Board will review and modify the Legislative Priorities and Legislative Proposals halfway through the two-year legislative session.

#### **PROPERTY TAX SHORTFALL**

Property tax revenue is the County's largest income source for covering the costs for essential but discretionary and mandated programs and is used to fund critical services to a diverse and dynamic population. Because the formula for distributing local property taxes has not changed since 1978, Orange County receives the lowest percentage of property tax revenue of any county in California – about six cents on the dollar.

#### GUIDING PRINCIPLES

The Board's four guiding principles are reflected throughout the 2017-18 Legislative Platform:

#### Funding Equity

The County supports equitable, dependable and predictable revenue streams to local governments that address equity among counties based on specified metrics.

Local Government Funding/Cost Recovery

The County supports efforts to require the state or federal government to fully reimburse the County for all costs related to mandated programs. The County will oppose efforts to raise local taxes to pay for new state or federal programs, efforts to redirect existing revenue streams away from mandated programs administered by the County, or expansion of service provisions without commensurate funding.

#### Local Control

The County supports efforts that maintain local discretionary control over its governance issues and delivery of services. This includes having flexibility to administer federal, state or local funding and programs, as well as maintaining decision-making authority over local land use.


## **Operational Efficiency**

The County supports proposals that encourage utilizing technology and innovation to streamline County Services. Furthermore, changes to state or federal law must not negatively impact the County's operational efficiency, and the County strongly supports efforts to eliminate unnecessary, redundant, or overlapping requirements or regulations for program eligibility, funding maintenance of efforts, monitoring, permitting or reporting.






#### **ORANGE COUNTY MAP**



#### ORANGE COUNTY: BY THE NUMBERS


Orange County's culturally diverse population continues to thrive throughout years. Thirty percent of the County's population is foreign born, while 46% of all residents over the age of 5 speak a language other than English at home. Many reside in Orange County to achieve the ultimate Southern California lifestyle; however, Orange County's prosperous reputation comes with a higher cost of living and few options for affordable housing. As a result, poverty is a daily struggle for many of the County's residents.


#### OC POVERTY BY RACE AND ETHNICITY: LIVING BELOW POVERTY 2014

#### COST OF LIVING INDEX COMPARED TO SURROUNDING COUNTIES 2014


The below cost of living indices are based on a US average of 100. Overall the cost of living in Orange County is 85% higher than the national average, making it the second highest when compared to its peers. Orange County's high cost of living is mainly driven by the cost of housing, which is estimated to be 347% higher than the national average.


#### AFFORDABILITY FOR FIRST TIME HOMEBUYERS

The below chart displays the regional comparison of the percentage of first-time homebuyers able to afford an entry level single family home. In 2015, an estimated 43% of households in Orange County could afford an entry level home. This number has dropped by 10% since 2009, making Orange County less affordable than all our neighboring counties, except San Francisco.



#### ■ POINT IN TIME HOMELESS POPULATION BY COUNTY 2013-2015


The Point in Time data for 2013 and 2015 includes both sheltered and unsheltered counts of the homeless. Based on the findings from the 2015 Point in Time data, approximately 4,452 individuals in Orange County are homeless on any given night. The Point in Time count is a biannual tally of people without a home on a particular night.

#### ■ ADULTS WITH MENTAL, EMOTIONAL, OR SUBSTANCE ABUSE PROBLEMS 2009-2014


The California Health Interview survey shows an increase of adults who need care for mental health or substance abuse issues. More than half of adults who needed care said that they did not get it in the past year. Behavioral Health continues to be a priority for the County. Today, the Orange County Health Care Agency's Behavioral Health Services has over 200 programs including children and adult mental health, alcohol and drug, crisis, and prevention/early intervention services.

#### ■ UNINSURED (BELOW 65) IN ORANGE COUNTY, CALIFORNIA, AND UNITED STATES 2010-2014

The number of uninsured residents under the age of 65 significantly dropped between 2013 and 2014, from 18.8% to 13.4%. While the number of uninsured residents continue to decline, the number of Medi-Cal enrollment has increased by 72% in the last two years.




#### ORANGE COUNTY MEDI-CAL AND CALFRESH CASELOADS FISCAL YEAR 2013-2016


