At the June 19, 2024, meeting, the establishment of an Ad Hoc Committee to review and evaluate the Commission to End Homelessness Bylaws was approved.

Review Process

The Bylaw Ad Hoc met a handful of times to meticulously review the Bylaws with the utmost integrity, ensuring an objective and thorough evaluation of every provision. The group's dedication to impartiality and rigorous analysis reinforced the credibility of the review process and reflected their deep respect for the Commission. Throughout this process, the Ad Hoc remained focused on the Commission's core principles while ensuring the Bylaws remained relevant, clear, and aligned with best practices and ethical standards.

Summary of Recommended Changes

- <u>Name</u> Revising the name of the Commission to the "Commission to Address Homelessness," provides a
 better description of the work that the Commission is doing as addressing homelessness is a multi-faceted
 approach and denotes that the work is active and ongoing.
- <u>Mission</u> Updated to provide clarity on the role of the Commission in Orange County and the work that goes into ending homelessness and integrates the established Homeless Service System Pillars into the Mission as it has guided the work of the Commission.
- <u>Article I, Purpose</u> Expanded to integrate the established Homeless Service System Pillars and delineated what the Commission is to accomplish in advancing the Mission.
- <u>Article I, Functions</u> Expanded to integrate the established Homeless Service System Pillars and detail the activities the Commission has already undertaken including supporting the evaluation and recommendation of strategies by considering regional policies; addressing homelessness prevention efforts; and conducting research, evaluation and education.

Summary of Recommended Changes

- <u>Article II, Membership</u> Updated to ensure that each Member on the Commission is well positioned in their role in the community, and their representation on the Commission, to help further the work of the Commission as detailed in the revised Mission, Purpose, and Function sections of the Bylaws.
- <u>Article III, Terms of Office</u> Reduce the Members terms of office from four (4) terms to two (2) consecutive full terms, becoming effective once the revised Bylaws are approved by the Board of Supervisors.
- <u>Article V, Commission Officers</u> Appointment of Chairperson and Vice-Chairperson has been updated to occur at the Commission's first meeting of each calendar year, as opposed to the last.
- <u>Article VI, Duties of Members</u> Expanded to memorialize the work Members of the Commission are already doing and help establish an expectation for interested candidates and new Members.

Approve Revisions to the Commission to End Homelessness Bylaws

Based on the Bylaws Ad Hoc's discussions, the recommended action is to:

 Approve revisions to the Commission to End Homelessness Bylaws to make changes to the name, mission, purpose and function, membership, and duties of members, as recommended by the Bylaw Ad Hoc to be submitted to the Board of Supervisors for final approval.

Transition Plan, if Recommended Action is approved

- December 2024 Commission approves revised Bylaws and establishes Membership Ad Hoc to recruit, evaluate and make recommendations for appointments for the August 8, 2024, expiring seats to the Commission at the February 2025 meeting.
- January 2025 Board of Supervisors to approve the revised Bylaws.
- February 2025 Commission to approve candidates as recommended by the Membership Ad Hoc and Membership Ad Hoc to recruit, evaluate and make recommendations for appointments for the December 5, 2024, expiring seats and new seats to the Commission at the April 2025 meeting.
- March 2025 Board of Supervisors to approve candidates as recommended by the Commission.
- April 2025 Commission to approve candidates as recommended by the Membership Ad Hoc.
- May 2025 Board of Supervisors to approve candidates as recommended by the Commission.
- June 2025 Commission fully transitioned to new membership as outlined in the revised Bylaws.

SECTION 8 HOUSING CHOICE VOUCHER PROGRAM (HCV)



What are Housing Choice Vouchers?

- Housing Choice Vouchers assist very low-income families to choose and lease safe, decent and affordable privately-owned rental housing
- U.S. Department of Housing and Urban (HUD) writes regulations to implement laws, distributes funding and monitors Housing Authorities
- Local Housing Authorities adopt discretionary policies contained in their Administrative Plan
- The family's income may not exceed 50% of the median income for Orange County, for 2024:
 - \$55,250 for Household of 1
 - \$63,100 for Household of 2

SECTION 8 HOUSING CHOICE VOUCHER PROGRAM (HCV)



How Do They Work?



Low-income families, elderly and disabled persons pay 30% (up to 40%) of their monthly income towards rent.

The voucher funds the difference between the tenant's portion and the approved contract rent.



Housing Choice Vouchers are mobile (portable). Tenants can move anywhere in the USA.



Any property owner can participate (unless a relative of tenant).

FOUR HOUSING AUTHORITIES IN ORANGE COUNTY





ORANGE COUNTY HOUSING AUTHORITY (OCHA) Covers 31 of 34 cities in Orange County



- OCHA administers the HCV Programs for households who reside or work in all cities of Orange County except Anaheim, Santa Ana and Garden Grove
- Assists about 13,000 households
 - Who is eligible? Income-based
 - Veterans
 - Elderly persons (62+)
 - Disabled
 - Families and individuals
 - Homeless
- Program size limited by budget authority
- Over 3,600 participating property owners



2012 WAITING LIST STATUS

More than 48,000 applicants applied for the OCHA waiting list in February 2012 (opened for two weeks). As of November 2024, the current number of applicants on the waiting list is approximately 1,850.




Out of those, about 100 applicants live or work in OCHA's jurisdiction.





2023 WAITING LIST STATUS



Waiting List opened September 2023.



OCHA received 57,506 applications during the k application period. OCHA randomly selected 12,000 applicants to be placed on the list.



OCHA will begin selecting names from the 2023 Waiting List as soon as the 2012 Waiting List has been exhausted.





Homeless Court Resource Fair

The Office of Care Coordination attended the Homeless Court Pop-Up Resource Fair in Chula Vista to learn more about how San Diego county is providing resources and assistance to people experiencing homelessness who are criminal justice involved.

The San Diego County Collaborative Partnership engages various resources from substance use disorder rehabilitation programs, Child Support Services, Homeless Court and its justice partners, and more in a single location to provide those experiencing homelessness with direct access to the Homeless Court Program, State and County services, and Community-Based Organizations.

The Office of Care Coordination is currently working to align resources in Orange County to host a similar event.

2025 Survey

The results of the 2024 Point in Time were presented to the Commission at the June 19, 2024, meeting. One of the statistics highlighted included the number of persons experiencing unsheltered homelessness for the first time in the past 12 months.

To explore the complex issues facing people who are experiencing homelessness for the first time in the past 12 months, the Office of Care Coordination will be focusing the 2025 Survey on this subpopulation to help better understand the causations of homelessness and identify areas for improvement.

Update

- The Office of Care Coordination has been working closely with City Net to formulate the survey questions and designing the survey implementation methodology.
- The Office of Care Coordination anticipates engaging the Commission, the Orange County Continuum of Care Board and the Lived Experience Advisory Board in the beginning of the year for feedback on the survey questions.

Homeless Prevention and Stabilization Pilot Program

The goal of the Homeless Prevention and Stabilization Pilot (HPSP) Program is to assist households who are at risk of experiencing homelessness achieve housing stability by providing financial assistance to pay rental arrears, past due utility bills, and forward rent and/or utility bills based on financial need, and stabilization payments.

Program Components:

- Case Management Focus on stabilizing household through care coordination intended to help participants navigate and address barriers to housing, connections to supportive services, and leveraging and utilization of CalAIM services.
- Direct Financial Assistance Rental arrears, past due utility bills, and forward rent and/or utility bills based on need, paid directly to landlord and/or utility company.
- Stabilization Payments Reoccurring financial payment of \$400 directly to the participant for up to 12 months.

Universal Eligibility Criteria

- Head of household is age 18 or older
- Household resides in Orange County, as confirmed via documents
- Household is at risk of homelessness, which means
 - The household does not have sufficient resources immediately available to prevent them from moving into an emergency shelter or another place not meant for human habitation; and
 - Meets one of the following conditions: currently in formal eviction proceedings or has been notified in writing that their right to occupy their current housing or living situation will be terminated within 21 days after the date of the application assistance.

Homeless Prevention and Stabilization Pilot Program

- As of December 2, 2024, more than 680 households have been pre-screened for eligibility.
- Of those, 110 households have passed pre-screening eligibility.
